Registration

Register your interest for the scheme

- Visit <u>www.cycle2work.info</u> and click the "employee sign up now" button
- Enter your personal details and employer code NORFOLKCC2012
- Select a unique username and password as your log in details (username must be in an email format)

Verification

Application

You will receive an email to verify your log in details

- You must click on the link within the email to verify the email address
- On completion you will be asked to log in to the portal
- If you do not have internet access please call the Halfords cycle2work team on 08450 778 850 and we will assist you further

Visit www.cycle2work.info

- Enter your log in details and click "Apply now"
- Complete your personal information including your preferred store location
- Select a Letter of Collection value within the minimum/maximum at increments specified
- Click "submit". You will then receive an email containing a link to your hire agreement
- To electronically sign, first you must agree to "Do business with Halfords electronically".
- Read the hire agreement then follow the instructions to electronically sign.
- When you have completed signing this will automatically be sent to your scheme manager for approval.

Approval

Once you have been approved you will receive an email containing your completed copy of the hire agreement, Letter of Collection and cancellation information
