## Changes to ABA membership fees

Due to recent changes in tax legislation, NCB has been advised that we need to charge VAT for all member services. This means we will be introducing VAT when we send invoices out this year. To help soften the blow we have frozen fees for another year, and have a new payment option whereby members can purchase 3 years of membership at a significantly reduced cost. We have also introduced a new category of 'Individual supporter' membership for any individuals that wish to join ABA. This means that if you are currently an individual with associate membership, it would be more appropriate for you to switch over to 'Individual supporter' membership. Please look out for the invoice in the post over the next few weeks.

## ABA launches new Department for Education funded programme of work

At the member meeting we were delighted to announce that ABA has received significant government funding under the DfE VCSE grants programme for a new programme of work to reduce the impact of bullying on the lives of children with special educational needs and/or disabilities. This work builds on previous research conducted by ABA and the University of Cambridge and will be delivered in partnership with Achievement for All (3As), Contact a Family and the Council for Disabled Children. The project includes a schools programme with 1500 Achievement for All (3As) schools to embed best practice in this area, dissemination and training to the wider children's workforce, and early intervention work with parents and carers of children with special educational needs and/or disabilities (led by Contact a Family and Mencap). In due course you will receive an invitation to sign up for regular updates on the programme as well as opportunities to take part in training events and input to policy work in this area. We would also like to take this opportunity to congratulate ABA members Kidscape, Beatbullying and the Diana Award who also received funding for anti-bullying work under the VCSE grants programme.

**Give us a break campaign: raising awareness of bullying of children with autism in our schools and colleges** We are delighted that our 'Give us a break' campaign in partnership with Anna Kennedy OBE has received so much press attention over the past weeks. We will be meeting with Sharon Hodgson MP in the next few weeks to tell her more about the campaign and encourage her support for tackling bullying of children with autism.

#### Safer Internet Day 2014 - 'Let's create a better internet together!'.

The UK Safer Internet Centre has confirmed the slogan for Safer Internet Day next year ' "Let's create a better internet together!" - a positive call to action appealing to all stakeholders to play an active role in making the internet a better place. Safer Internet Day 2014 will take place on Tuesday, 11 February 2014. ABA and Childnet International will work together to align Anti-Bullying Week 2013 with the Safer Internet Day campaign as there are such similar themes and messages this year.

Article in the <u>Guardian</u> on new research published by Child Helpline International (CHI) shows significant rise in calls relating to cyberbullying.

#### Overprotected children 'more likely to be bullied'

Research suggesting that children who have overprotective parents are more likely to be bullied by their peers has appeared in various media reports. An analysis of 70 previous studies totally more than 200,000 youngsters identified poor parenting as an important and overlooked factor in childhood bullying. Professor Dieter Wolke, of Warwick University, who led the research said: 'Parents who try to buffer their children from negative experiences prevent them from learning to deal with bullies and make them more vulnerable.' #### Here's why your SnapChat photos aren't private

This brief article explains why the SnapChat app - popular with teenagers - is not as private as people think. SnapChat is a self-deleting photo app that lets users can take a picture using their phone, add text if they want, and then set how long - between one and 10 seconds - they want their friend to be able to view it before it disappears from both phones. However, a workaround allows the recipient take a screenshot without the app letting the sender know. This means it can be shared anywhere. At a high school in New Jersey, USA, two boys are accused of posting Snapchat photos they received from at least one girl on Instagram. Police are investigating.

## 'Neighbours' stars combat cyberbullying in video

Neighbours stars James Mason and Jenna Rosenow have spoken out about cyber-bullying in a new video released by the soap. The Australian soap opera has been tackling the issue in one of its storylines as Rosenow's character Amber Turner became involved in a Twitter war with another pupil at her school. Addressing fans in an official Neighbours video, Rosenow explained: "Because these posts are seen by a large number of people and can be left online for a long period of time, the effects of cyber-bullying can be very damaging, leaving those who are being bullied feeling alone, afraid and rejected." She continued: "Everyone has a role to play in stopping bullying. Even if you're not the one that starts it, but you follow it, watch it or send it, then you're actually part of the problem." #### Parkside School anti-bullying champions offer peer workshops

Anti-bullying champions at Parkside School, Keighley, Yorkshire have been delivering workshops to younger students. Year eight and nine students enjoyed teaching and supporting pupils about the topic. Anti-bullying co-ordinator, Robert Johnson, said: "The champions devised their own interactive approach to involve the classes in some very good roleplaying of coping strategies. Although anti-bullying is a serious matter, there have been opportunities for fun, while reinforcing the message to 'tell someone' if you or somebody else is been bullied."

## Pupils report bullying to their teachers by text message

An article in the <u>Independent</u> reports that children can now text their teachers to report bullying in an initiative that makes it safer to come forward. Leicester City Council is pioneering the initiative by becoming the first authority in the country to give all its schools software, which enables their pupils to report instances "24/7" via text, phone and online. The system also has the advantage of allowing a bystander to report an instance of bullying, even if they are not the victim.

## Amscreen donates digital advertising billboard for national anti-bullying autism campaign

Amscreen, the UK's largest digital media owner, is supporting a national anti-bullying for autism campaign, by screening the adverts on their digital outdoor network for free, reaching 20 million people per week for a two week period. Amscreen is a flexible network of 5,000 screens located in a range of forecourts, local convenience outlets including WHSmith and doctors' surgeries across the country. The campaign is calling for laws to be changed to protect those with autism who are victims of cyber bullying, trolling, stalking and verbal abuse. Kevin Healey, the campaign leader, who is also shown on the billboard, and who suffers from autism has been targeted by online 'trolls' since childhood, has set up the campaign to call for better support and services for those with autism, and other vulnerabilities.

# Policy and legislation update

#### Parliamentary question: Academies: Homophobia

On 23 April in the House of Commons, Kate Green, MP for Stretford and Urmston, asked the Secretary of State for Education what residual duties local authorities retain in relation to ensuring academy schools comply with the provisions of the Equality Act 2010 and the public sector equality duty in relation to addressing homophobic bullying. Edward Timpson, Under Secretary of State for Children and Families, replied: "The Equality Act 2010 does not place any duties on local authorities to ensure that schools comply with their responsibilities under the Equality Act 2010. There is, therefore, no role for local authorities to ensure compliance for academies. Under the Equality Act, local authorities have a duty not to discriminate when carrying out their own education functions-such as organisation of schools and arranging admissions. The Equality Act clearly sets out the responsibilities on schools and academies in respect of the discrimination provisions and the equality duties, and they are responsible for ensuring their own compliance."

## SWGfL Whisper - an anonymous reporting tool for schools

A new app from South West Grid for Learning (SWGfL) - titled Whisper - integrates with your school's website and allows children, parents and staff to report issues anonymously to the school. It is a direct reporting channel, a virtual 'bully box' or a simple way of recording incidents or obtain evidence.

Whisper is part of SWGfL BOOST - a recently launched new suite of esafety tools and resource, available for £199/ year to schools (£99 for SWGfL schools).


- Give participants a theoretical understanding of different types of abuse, the excuses perpetrators give and the extraordinary pressure on
