The Pitch Small Business Competition - Deadline Extended

People's Health Trust - Active Communities Programme Open to Applications (GB)

The Active Communities Funding Programme aims to close the gap between those communities which experience the worst health in England, Scotland and Wales and the majority of the population.

The programme focuses on people living in the poorest neighbourhoods because they will, on average:

- Die seven years younger than people living in richer neighbourhoods.
- Spend 17 years more of their shortened lives with disability than people living in richer neighbourhoods.
- Have higher rates of mental health problems.
- Have a lower quality of life.

The programme offers grants of between £5,000 and £25,000 to local charities, community groups and social enterprises for projects run by local people that address issues relevant to them, and that benefit and improve their local community. Projects must take place within a small area for a small group of people and can run for between nine months and two years.

Launch of the 2013 Adam Reynolds Memorial Bursary

This Bursary is offered is in memory of Adam Reynolds who died in 2005. Adam was a Chair of Shape and renowned sculptor and activist for disability equality in the arts. Shape is a charitable company aiming to achieve access to the arts for disabled and deaf people.

The Bursary provides an opportunity for disabled or deaf artists to develop their ideas and practice without pressure to deliver a particular outcome. The successful applicant receives a grant of £5,000 and a three-month residency at Spike Island - an international centre for the development of contemporary art and design - in Bristol in winter 2013/14.

The artist will also be able to benefit from support and advice from the Artists Professional Development team at Shape.

The Bursary intends to provide time, space and support for artists to work in an open-ended way for a period of three months. The grant may be used to cover any costs associated with this work, for example:

- Hiring equipment.
- Purchasing materials.
- Paying for assistant artists or technicians in order to realise a particular work.

Disabled or deaf visual artists based in the UK may apply to this programme. Applicants must demonstrate that they have been making and showing work for over five years.

They have launched the second scheme for 2013, supporting community theatre. The Community Theatre scheme aims to support groups of non-professional performers that have been active since 2011. With no other restrictions on performer background or genre of theatre, they are looking for groups that have ambition and wish to raise their profile locally. Eligible groups can apply for grants between £500 and £5000 to be used on one-off projects. They want to encourage groups to take on more challenging projects through commissions and encouraging collaboration with professional theatre makers and other local organisations, with an eye towards raising their profile in the local community. DCLG Neighbourhood Planning Grants (England)

The Department for Communities and Local Government has announced the launch of a new £9.5 million fund to support Neighbourhood Planning. The Localism Act 2011 introduces statutory Neighbourhood Planning in England. It enables communities to draw up a Neighbourhood Plan for their area and is intended to give communities more of a say in the development of their local area. The Supporting Communities in Neighbourhood Planning programme will support groups developing neighbourhood plans in two ways. These are:

- Direct support: advice and support, tailored to meet the needs of supported neighbourhoods;
- Grant payments of up to £7,000 per neighbourhood area, to contribute to costs incurred by the group preparing a neighbourhood plan or order.

 Support is available to town and parish councils, neighbourhood forums and emerging neighbourhood forums preparing a Neighbourhood Development Plan. The first stage of the

application process is to complete the eligibility checker to find out if your group is eligible for direct and/or grant support. If you are eligible, you will be emailed a link to your application form within 24 hours. Read more at: http://mycommunityrights.org.uk/neighbourhood-planning/

Grundtvig Visits and Exchange Grants (UK)

Adult education staff wanting to improve their practical skills and to gain a broader understanding of lifelong learning across Europe can apply for funding to attend a seminar, conference, job shadowing and training in another European country. Visits and Exchange grants are offered under the Grundtvig part of the Lifelong Learning Programme. The Grundtvig programme aims to strengthen the European dimension in adult education. Funding is open to those involved in adult education. Activities can last between one day and twelve weeks and are a great way for you to improve teaching, coaching, counselling or mentoring skills. Grants are available to contribute towards the total costs incurred, including:

- Conference or seminar fees
- · Travel
- Subsistence and other costs.

Funding for Youth Music Making Activities (England)

To help with this, Youth Music will consider applications for programmes where up to 25% of the time is spent in school hours. Schools in the UK, that wish to purchase musical instruments and equipment can apply for funding of up to £2,000 through the EMI Music Sound Foundation's Instrument and/or Equipment Awards. To date the Foundations has made awards to over two thousand schools, individual students and teachers improve their access to music through the purchase or upgrade of musical instruments and equipment. The funding has to be made for music education that is beyond statutory national curriculum music teaching. The Foundation cannot fund retrospectively and schools are not eligible for financial assistance under this scheme if they have already purchased their instruments or if they do so before their application has been approved. Time to Change Grants (England)

The Mental Health charity, Time to Change has announced that its grants programme will re-open for applications on the 17th July 2013.
