There is a 90 % probability of heatwave conditions between 0900 on Wednesday and 2100 on Thursday in parts of England.

An update will be issued when the alert level changes in any region. Alerts are issued once a day by 0900 if required and are not subject to amendment in between standard issue times. Note that the details of the forecast weather are valid at the time of issue but may change over the period that an alert remains in force. The areas that are likely to be affected are:

General Comments:-

High temperatures are expected to continue across much of England over the next few days. Temperatures are expected to reach or come very close to Level 3 Heat Health Watch criteria in London and Southeast England. Elsewhere temperatures may come close to criteria, however certainty is lower, giving a Level 2 Heat Health Watch in all but the North East and North West of England.

Organisations providing health and social care should be aware of the advice and guidance set out in the Department of Health's Heatwave Plan, as to the actions necessary before and during a Level 2 or Level 3 heatwave. Specific advice to be followed by health care professionals, and the managers and staff of residential and nursing homes in the event of a heatwave is available from the Department of Health website www.gov.uk/government/publications/heatwave-plan-for-england-2013 and Public Health England's website www.gov.uk/government/organisations/public-health-england.
