Call to 'Have your Say' as County Council launches 12 week public consultation as it bids to bridge £189m funding gap

Views are being sought from Norfolk residents over the next 12 weeks on how Norfolk County Council should plug a predicted £189 million funding gap.

The gap has been caused by a £91 million cut in government grant, coupled with rising public demand for vital services, which the council is having to tackle by:

*Finding extra efficiencies from budgets and new ways of working, generating new income and driving down things like contract costs, to save more than £74m. A further £6.6m will come through savings already agreed.

*Cutting some services and stopping others altogether so that the Council can balance its books when it sets next year's budget.

The Council is today (19 September) launching a 12 week consultation promising to listen carefully to the public's views on dozens of different savings proposals in its Norfolk Putting People First consultation and inviting alternative suggestions.

Despite the seriousness of the situation, there are no proposals to close fire stations, libraries or recycling centres and no reductions in winter gritting routes. Recently announced investments to recruit more staff in child protection and strengthen the strategy to support school improvement are unaffected by these proposals.

Once the consultation process is finished, the feedback will be considered by county councillors at meetings during January before Full Council agrees a budget for 2014-15 on 17 February next year.

Gathering evaluation and feedback from your audiences or visitors can be expensive and time-consuming for arts and culture organisations. Using a newly developed open source app, the Qualia project is making the evaluation process much easier for such organisations, while enhancing the audience experience by providing key information. Cheltenham Festivals have hosted the development of the new Qualia app, which will be made available to all arts and culture organisations later in the year. The app and associated website and analytics are being created by experts led by Prof Mike Phillips (Plymouth University) and Dr Eric Jensen (University of Warwick), with funding from Nesta, the Arts & Humanities Research Council and the Arts Council through the Digital R & D Fund for the Arts.

This event on 10 October is for those working in organisations that seek to engage publics with arts or culture (culture is very broadly defined, including all museums, festivals, science centres, zoos, etc.). The Josef Herman Art Foundation Cymru (JHAFC) is a registered charity. It was founded in 2002 to encourage, through exhibitions, the public appreciation of the visual arts by people of all ages, and to honour the artist Josef Herman and his legacy. In 2013 the JHAFC is entering into a two year partnership programme with Tate Britain as one of their regional partners in their 'Transforming Tate Britain: Building, Archives, Access' programme. The programme aims to reach beyond Tate's walls, through regional partnerships and via the Interactive Learning Hub online, offering a range of digital resources and participatory features. Through its exemplary programme, Tate Learning will be a catalyst for a deeper and wider engagement with arts, culture and heritage for all to enjoy. The programme title for the JHAFC regional programme is Mining Josef Herman. The programme is supported by the Heritage Lottery Fund and the JHAFC has also received support from the Arts Council of Wales. The JHAFC is offering 2 contracts:

Call for organisations for a-n critical writing bursaries

Digital Makers Fund - Second Call Open to Applications (UK)

The Digital Makers Fund, provided by Nesta, is designed to support innovators with bright ideas for significantly increasing the number of young people who participate in 'digital making' activities.

Digital making is described as the creative process of making a product or digital artefact - from websites, apps, games, and 3D animations to physical objects driven by microcontrollers. The programme will feature a series of funding opportunities. The current round (round 2) has a total budget of £250,000 and individual grants of between £20,000 and £50,000 are available. Alongside the grant, a package of tailored support will be offered, including advice and mentoring and access to expertise and networks, desk and event space.

Ideas that lead to the creation of digital products that can be widely shared will be funded. The emphasis is on new products that can help teach digital making skills in new ways or drive participation from new groups of users. Examples of where funded ideas may feature include the internet, home, clubs, work, play, camps, school, shopping centres, sporting events and gigs.

Nesta is inviting applications from organisations across the UK that have the ability to engage young people in digital making activities. Proposals are welcome from all sources and sectors and all types of organisations - communities, charities, social enterprises, businesses, academia and public services.

The deadline for receipt of applications for the second open call is 14 November 2013. To accompany the application, applicants must submit a short video pitch of no more than two minutes and a short application form that captures some basic information about the idea and organisation. www.nesta.org.uk/

Esmée Fairbain Trust

Esmée Fairbairn aims to improve the quality of life throughout the UK. They do this by funding the charitable activities of organisations that have the ideas and ability to achieve change for the better. The Foundation like to consider work which others may find hard to fund, perhaps because it breaks new ground, appears too risky, requires core funding, or needs a more unusual form of financial help such as a loan. The Radcliffe Trust has announced that the next deadline for applications to its Music making grants programme is the **31st January 2014**. Particular interests within music education are music for children and adults with special needs, youth orchestras and projects at secondary and higher levels, including academic research. Heritage Grants over £2 Million & under £5 Million (UK) Closing date: 17 October 2013

The Heritage Lottery Fund has announced that the next closing date for applications to its Heritage Grants scheme for project of over £2 million and under £5 million is the **17th October 2013**. Under the Heritage Grants scheme funding is available for projects that relate to the national, regional or local heritage of the UK. To be eligible for funding a project must:

- Help people to learn about their own and other peoples heritage
- · Conserve the UK's diverse heritage for present and future generations to experience and enjoy
- Help more people, and a wider range of people, to take an active part in and make decisions about heritage.

HLF welcome applications from single organisations and partnerships. Priority is given to not-for-profit organisations, and partnerships led by not-for-profit organisations. If private owners are involved, HLF expect the public benefit to be greater than any private gain. In addition, the HLF also makes grants of £100,000 - £2 million; and Grants in excess of £5 million. Heritage Enterprise Programme (UK) Closing date: 17 October 2013

The Heritage Lottery Fund has announced that its £125 million Heritage Enterprise grants programme is open for applications. The scheme aims to support not-for-profit organisations to help them work in partnership with the private sector in the restoration of unused historic building and sites and unlock their economic potential. The programme is designed to address market failure, where historic buildings have failed to attract enough investment because the cost of their repair has not been commercially viable for private developers.

Under the programme two level of grants are available:

- Grants of between £100,000 and under £2 million
- Grants of between £2million and £5million.

For grant requests of over £100,000 and under £2million decisions are made every three months. For grant requests of between £2 million and up to £5 million the next closing date for applications is the **17th October 2013**. Read more at: http://tinyurl.com/os4wry4.

The Arts Council, England has announced that its Strategic Touring Programme has re-opened for applications. The £45 million Strategic touring programme aims to encourage collaboration between organisations, so more people across England experience and are inspired by the arts, particularly in places which rely on touring for much of their arts provision. The funding is available to both organisations and individuals. Partnerships, networks and consortia can also apply. These can include:

Priority is given to applications that focus upon the perfection or promotion of the art in question. Additionally for those applications involving young people the trustees look to a long-lasting connection between them and the art form, one which aims at a significant level of participation and achievement, rather than projects that offer little scope for further involvement. Once you have completed the questionnaire the Grant Manager for your region will be in touch to discuss whether or not your work is eligible and if it is the next steps. The Foundation's application form is available only after you have spoken to the local Grant Manager.
