Norfolk & Norwich Open Studios 2014 - now open for applications

Norfolk & Norwich Open Studios welcomes applications from all artists, groups of artists and schools who wish to attract a wider audience to see their work. There is no selection process for entry to the scheme; the only requirement is that the studio or school you are opening is based in Norfolk.

Register and apply online at www.nnopenstudios.org.uk/register

The deadline for receipt of completed applications is 5.30pm, Friday 13 December 2013. There is a participation fee for the scheme. For individual artists and schools, the membership fee is £100. If there are other artists exhibiting in your studio / venue they must also pay the individual membership fee, or you can pay the group membership fee to cover all the artists in that one venue.

The membership fee for artist group membership fee is £280. Group membership is defined as being members that are not specifically individual artist open studios and / or are run or occupied by more than one person. It can be beneficial to participate in NNOS as a group if there are more than 3 artists in one venue.

The membership fee includes:

A listing, an artist profile and artwork image in the NNOS brochure (distributed county wide); an all-year-round NNOS website listing; access to various marketing materials; opportunity to exhibit a piece of your artwork as part of the Central Taster exhibition at the Forum in Norwich, which runs from Thursday 17 April-Wednesday 23 April 2014 (hanging date tbc); opportunity to exhibit as part of a taster exhibition in your district (subject to demand and an artist volunteering to coordinate this in your district); the NNOS evening launch reception (date tbc, the Forum, Norwich); press, PR and marketing support for the scheme as a whole.

Many NNOS artists also get together to form Art Trails, an ever growing element of NNOS. These trails form pathways of studios through the county and encourage visitors of the scheme to make it a 'day out' opportunity. Artists also organise additional events to their open studio such as afternoon teas, talks, demonstrations and classes / tuition, which attract larger audiences and give visitors the opportunity to actively participate in the scheme. Call to 'Have your Say' as County Council launches 12 week public consultation as it bids to bridge £189m funding gap

Views are being sought from Norfolk residents over the next 12 weeks on how Norfolk County Council should plug a predicted £189 million funding gap.

The gap has been caused by a £91 million cut in government grant, coupled with rising public demand for vital services, which the council is having to tackle by:

*Finding extra efficiencies from budgets and new ways of working, generating new income and driving down things like contract costs, to save more than £74m. A further £6.6m will come through savings already agreed.

*Cutting some services and stopping others altogether so that the Council can balance its books when it sets next year's budget.

The Council is today (19 September) launching a 12 week consultation promising to listen carefully to the public's views on dozens of different savings proposals in its Norfolk Putting People First consultation and inviting alternative suggestions.

Despite the seriousness of the situation, there are no proposals to close fire stations, libraries or recycling centres and no reductions in winter gritting routes. Recently announced investments to recruit more staff in child protection and strengthen the strategy to support school improvement are unaffected by these proposals.

National Leisure & Culture Forum Leading Learning Programme 2014

The NLCF Leading Learning Programme is open for recruitment for 2014. The timetable for recruitment and delivery runs from Sept 9th to Dec 9th 2013.

The NLCF is an association of professional bodies representing managers across the fields of culture and leisure. The NLCF Leading Learning Programme was generously supported by the Cultural Leadership Programme as the first leadership programme to be specifically aimed at the cultural sector within local government. It is now supported by professional associations in membership of the NLCF to support the leadership development of all their members. It has five main support elements:

- Initial 360 degree assessment of your leadership strengths and potential.
- 7 days of residential sessions to allow you to meet inspiring exemplars, reflect on your own practice and challenge your knowledge and skills.
- Monthly one to one mentoring sessions with a well matched senior figure with extensive cultural and/or local government experience and expertise.
- Five bi-monthly facilitated action learning sets organised for North, South, East & West. From 2014 virtual action learning sets may also be available.
- A website with further reading, participants' forums and development opportunities.(www.ncfleadinglearning.co.uk)

The programme is aimed at:

- senior managers of Cultural and Leisure Services in local government,
- senior staff of agencies who work closely with local government
- directors/senior managers of companies and trusts that deliver outsourced services for local authorities
- senior managers of cultural and leisure organisations (both public and private sector)
 who wish to improve their ability to work in the political context

We would expect participants to have overall responsibility for more than one area of cultural services, but because local authorities and cultural organisations have such varied structures we aim to be flexible. People currently managing Cultural Services may not even have a Cultural Services background. What's most important is an ambition to succeed in the workplace and to extend the creative and innovative perspectives of cultural services to influence the wider political agenda. It is open to managers and officers from all four nations, England, Scotland, Wales and Northern Ireland.

The subsidised cost in 2014 of each place is £4,000 + VAT for local authorities and charitable trusts and £5,000 for commercial companies and national cultural bodies and there is an early bird discount of £500 for those applying by November 11th. For 2014 we also have a few bursaries worth £1000 or £1500 each, bringing the price down to well below its true cost. Please contact the Programme Director if you would like further details of these. We are also prepared to stagger invoicing so that fees can be spread across two financial years. Applications will be received by e-mail only and up to midnight on 9 Dec 10th 2013. All applications will be assessed by the Director of the programme and the Leading Learning steering group. Cambridge Arts Network would like to invite you to join us to discuss the outcomes of Cambridge City Council's commissioned research into the City's arts infrastructure. Recent consultations with the Cambridge arts sector have highlighted an unmet demand for creative workspace, artists' studios, office, performance, rehearsal space and noted a lack of a major multi-arts centre in the City.

In response to these concerns and the Cambridge Local Plan, Cambridge City Council commissioned Business of Culture in March 2013 to carry out two interrelated studies to enable us to identify gaps in provision and potential improvements in arts infrastructure – an audit of the City's current arts facilities and an analysis of artists' and arts organisations needs for creative space.

We believe that now is the right time to come together and discuss the outcomes of this research and establish the key issues, opportunities and challenges faced by Cambridge's arts infrastructure, the broad strategic objectives we need to set in order to meet these challenges, and the actions we can take to ensure that Cambridge has a strategy that supports the needs of a growing population and arts community.

Through a combination of keynote speakers, national and local case studies, facilitated discussions and breakout sessions; the conference aims to answer the following questions:

- Why are arts and culture vital to a City's infrastructure and planning process?
- What approaches have been used by other cities to ensure that arts infrastructure reflects their needs?
- Is Cambridge's arts infrastructure currently being met by the City's existing cultural assets?
- What is the future demand for creative arts space in Cambridge?
- How will Section 106 and the Community Infrastructure Levy support the growth of Cambridge's arts sector?
- What can arts organisations, groups, practitioners and City Council contribute to the planning process and what are the opportunities to influence the Cambridge Local Plan?
- How can we identify opportunities for arts infrastructure development and address gaps in provision?
- What can we learn from local case studies and examples of new or enhanced arts facilities?
- How can we drive the provision of enhanced or new cultural and arts facilities, services and activities through the planning process?

As an exciting, ambitious and much loved small arts charity, we have a vacancy for a retired or currently employed qualified accountancy professional wishing to serve as a Trustee and Honorary Treasurer.

Norwich Puppet Theatre is a much-loved and very active small arts charity with more than 30 years of track record in providing excellence in puppet theatre performances and education for audiences of all ages.

Our strategy is to develop our unique cultural venue in St James', Whitefriars, Norwich into a centre of excellence in puppet theatre, one of only two such dedicated facilities in England. As a charity, oversight of our professional artistic management team is by a Board of Trustees, and we have a vacancy for a qualified accountancy professional wishing to serve as a Trustee and Honorary Treasurer.

The role would be filled in an entirely voluntary basis. The person appointed would have responsibility to provide strategic rather than hands on oversight of the work of the staff who undertake the bookkeeping and financial processes of the business.

The role would include additionally leading the Board's Finance sub-committee, and help the Board in its assessment of the company's financial health and planning. The Treasurer would have a key role to play in providing the Board with a financial perspective on strategic priorities and business plans.
