The David T. K. Wong Fellowship, University of East Anglia

The David T.K. Wong Fellowship is a unique and generous annual award of £26,000 to enable a fiction writer who wants to write in English about the Far East to spend a year in the UK, at the University of East Anglia (UEA) in Norwich. The Fellowship is named for its sponsor Mr David Wong, who, after a career as a business man and civil servant, is a writer of novels and short stories.

Terms and Conditions

Applications for the Fellowship will be considered from established published as well unpublished writers of any age and any nationality. The Fellowship will be awarded to a writer planning to produce a work of prose fiction in English which deals seriously with some aspect of life in the Far East (Brunei, Cambodia, Hong Kong, Indonesia, Japan, Korea, Laos, Macau, Malaysia, Mongolia, Myanmar, People's Republic of China, Philippines, Singapore, Taiwan, Thailand and Vietnam).

The successful candidate will be selected by a distinguished international panel. There will be no interviews, and candidates will be judged entirely on the quality and promise of their writing and the project they describe.

Fellows take up their appointments on 1st October each year.

The Fellows will be a member of the School of Literature, Drama and Creative Writing and will be required to reside at UEA, Norwich, UK for 9 months, accommodation will be provided on campus, to be paid for by the Fellow out of the Fellowship Award. Shared office space and computer facilities will be made available for the Fellow in the School. During the residential period, the Fellow will be required to submit written work to a nominated mentor and take part in Creative Writing Research Seminars. No teaching duties attach to the Fellowship.

The Charles Pick South Asia Fellowship, University of East Anglia

The Charles Pick South Asia Fellowship is dedicated to the memory of the distinguished publisher and literary agent, Charles Pick, whose career began in 1933 and continued until shortly before his death in January 2000. He encouraged young writers from the start of their careers with introductions to other writers and practical and financial help. The Fellowship seeks to continue the spirit of encouragement by giving support to the work of a new and, as yet, unpublished writer of fictional or non-fictional prose. Its purpose is to give a promising writer time to devote to the development of his/her talents.

The Fellowship is for six months, starting on 1 October 2014. The award is £10,000 and includes campus accommodation.

Terms and Conditions

Applicants for the Charles Pick South Asia Fellowship must be writers of fictional or non-fictional prose in English who have not yet published a book (please note that for the purposes of the Fellowship non-fiction prose includes, for example, biography, memoir and travel writing, but not critical or historical monographs based on academic research). The Fellowship is for the purpose of completing a major work.

Applicants for the Fellowship can be writers of any age. The writer should be from South Asia (Afghanistan, Bangladesh, Bhutan, India, Kazakhstan, Kyrgyzstan, Maldives, Burma/Myanmar, Nepal, Pakistan, Sri Lanka, Turkmenistan, Tajikistan, Uzbekistan), but does not need to be domiciled there.

EU cultural funding

The EU has launched Creative Europe, the new EU-wide culture strategy and the accompanying funding programme (currently being ratified by member states and to commence next year). The new strategy promises a holistic vision for the development of the creative industries in Europe, and this passes down to the proposed funding programme too; whereas before there were separate, biddable strands for Culture and Media, these will now be combined into a single initiative which will allocate up to €1.46 billion between 2014 and 2020. The overarching mission for the programme is to foster and promote 'smart, sustainable and inclusive growth' across the EU's cultural industries. There's an immense opportunity here, but research from the previous programme confirms the suspicion that UK cultural organisations do not engage as strongly as partners from other countries. From the information available so far, the new programme goes a long way to addressing and surmounting these and other obstacles to participation. But how can London and wider UK-based organisations really get to grips with the opportunities arising? A good initial step would definitely to be to sign up to, and to read, the European Commission's Culture and Education Newsletter and the European Cultural Foundation's Newsletter; and to also subscribe to Visiting Arts' E-bulletin, for information on the transition from the 2007-13 to the 2014-20 programmes.

Queen Elizabeth Scholarship Trust - Announcement of Spring 2014 Intake

New Fund Launched to Support Innovative Music and Education Partnerships

Exchanging Notes is a new grants module launched by Youth Music to support partnership working between schools and specialist music education providers. The aim is to enable young people at risk of low attainment, disengagement or educational exclusion to achieve the best musical, educational and wider outcomes.

It is expected that around 10 projects will be funded across England. Partnerships will be funded to develop music and education practice through an approach to teaching and learning that places an equal focus on personal and social outcomes as well as musical outcomes, capitalising on young people's passion for music with the aim of bringing about extended benefits to support their educational engagement and attainment.

The fund is based on research findings from a study commissioned by the National Foundation for Youth Music on the experiences of learners in music education settings outside school, and in particular how this related to experiences of in-school music. The study found that partnership-working between schools and other specialist music organisations was a positive and valuable process with practitioners recognising strengths in different methods of delivery and learning from one another. Following on from this, the work delivered through Exchanging Notes will be subject to an independent longitudinal evaluation, coordinated and funded by Youth Music. WREN Grants

WREN (Waste Recycling Environmental) grants provide support for environmental and community-based projects in areas of England, Scotland and Wales close to Waste Recycling Group landfill sites. Projects must provide public amenities or parks; conserve biodiversity; or restore buildings for worship or which are of historic/architectural interest. There are three grant programmes:

- Small Grant Scheme: Grants between £2,000 and £15,000 are available. The total project cost must be under £50,000. Up to 100% of project costs may be funded.
- Main Grant Scheme: Between £15,001 and the maximum total project cost of £75,0000. Up to 100% of project costs may be funded.

Changes to NPO Funding in England

Arts Council England is preparing to divide its National Portfolio Organisations (NPOs) into two groups from 2015/16 – those that will be funded from Government Grant-in-Aid (GiA) and those that will be paid from Lottery revenues. This new approach to core funding was announced at a briefing meeting for leaders of existing NPOs and major museums at an invitation-only gathering at mac in Birmingham last week. Delegates were told that there will be no need for organisations to consider whether to apply for one category of funding or the other, as the decision as to which type of funding will be awarded will be made by ACE. Deputy Chief Executive Althea Efunshile told the meeting that certain types of "people-focused" organisations are likely to be Lottery-funded in future, and cited circus, participatory arts and festivals as examples. Under the law governing National Lottery distribution, Lottery proceeds must be distributed in response to open applications and the cash must be for time-limited activities which are 'additional' to those normally or currently funded from Government sources. The meeting also heard of ACE's investment plans for 2015-18. ACE is forecasting a 5% cut in its NPO budget for 2015/16 and standstill from there for the following two years. The amount of Lottery money allocated to NPOs will grow and there will be a small increase in Grants for the Arts. Delegates were told to use 2014/15 figures as the starting point for their next NPO applications but to make their bids 'scalable', making clear the implications if they were to be given less than they hope. They were told to expect fewer changes to the composition of the National Portfolio than in the previous funding round, and that very few organisations would see a funding increase: London will also not get more than at present.

NPOs will, however, be eligible to apply for additional Lottery cash from other strategic funding programmes. Full details of these will also be published when the application period for NPO status opens in January, and Efunshile told delegates that this was to enable them to take account of alternative ACE funding sources when preparing their NPO applications. Having said this, the total value of strategic budgets will be reduced by around 20%, and ACE will look to cut these first if there are further cuts to its Government funding.

The Birmingham meeting was one of a series held around the country from 5-7 November. Although the next round of applications for National Portfolio status will be open to all, the briefings were only for current NPOs.
