Are you, or somebody you know, in a local band, school or community choir? If so, you could **win** a free day's recording with Travelling Studio, a new company based in Norfolk who specialise in recording large music groups on location.

They are running the competition to celebrate their recent launch, and to enter you simply need to let Travelling Studio know what your favourite piece of music is, and what it is that you like so much about it. The ten best answers will be placed in a prize-draw with the lucky winner to be announced in Spring 2014.

Founded by musician and recording engineer Paul Thompson, the company's philosophy is to take the worry out of the recording day by bringing their equipment to your place of choice.

"For music groups such as schools and choirs, trying to organise a large group of people getting to a studio can be logistically very difficult. It can also be quite daunting to stand in front of a microphone for the first time. Recording in an environment you know and feel comfortable with will often produce the best results because you are basically relaxed."

Able to draw on his experience as a professional touring and recording musician, Paul built his own home studio after being dissatisfied with the results from a local studio. He recorded 3 CDs of his own music which got rave reviews in the national music press, and people soon started asking him to do recordings for them. Travelling Studio is an all-in-one service including CD design and duplication, and a youth orchestra from Sheringham has already toured Norway funded by the proceeds of CDs. The project is part of LibraryFest2014, which runs in Hungerford, Newbury and Theale libraries from 6th March to 23 April 2014. It is a mixture of live performance events, visual arts, craft activities, installations and book-related opportunities. "Wish you were here?" supports a universal programme where any member of the public who may live, work or play in the district is invited to submit a postcard depicting a favourite or memorable place in the district — past, present or future. This is in any medium and may be text or picture based. We wish to commission a digital artist as part of LibrayFest who is experienced in working with

Access All Areas: disability and youth arts

3rd April 2014, 9.45 am- 4 pm

The Garage, Norwich Special Rate Fee: £75 p/p

This one day course is designed to encourage a broader exploration of equal opportunities within youth arts. Participants will develop an understanding of the importance of inclusive practice, through looking at political and cultural contexts, and exploring practical ways of ensuring youth arts projects and venues are genuinely inclusive to young disabled people. The course will leave participants feeling confident about their responsibilities, and inspired to engage in youth arts practice with young disabled people.

Putting Young People at the Core of Youth Arts

Putting young people at the core of youth arts is a one day course designed to demonstrate how young people can be empowered more effectively as decision makers at the core of youth arts. The course will examine the benefits of integrating young people's voices into your organisation, both in terms of benefits for your organisation and for the young people involved. The course will include inspirational examples of young people who are working at the core of youth arts and a wide range of practical tips about how to involve young people more fully in your own work. This one day course follows the journey of youth participation - exploring attitudes towards young people as decision makers and the routes that a young person can take from being a youth arts project participant to an active and informed decision maker in an arts organisation. It then moves onto exploring your current practice before celebrating the range of structures available in the youth arts sector for putting young people at the core of an organisation. The day concludes with a reflection on your own practice and your aspirations for involving young people in your future work.

Invitation to Tender: Tour de France - Artistic Commission

The Tour de France's visit to the UK in 2014 is a rare opportunity and one not to be missed. The city of Cambridge will be on the world's stage and it is anticipated that at least 50.000 people will come to see the start of the Tour in the city on Monday 7th July 2014. New programme for disabled artists (England & Wales)

Following the successful Unlimited project which was at the heart of the London 2012 Cultural Olympiad and celebrated the work of disabled artists, Shape and Arts admin have been awarded £1.5 million by Arts Council England to deliver a new three year commissioning programme to support disabled artists in developing ambitious and high quality work, will be delivered throughout England and Scotland. 'Unlimited' will not only help disabled artists develop their practice and encourage the development of new relationships and collaborations with producers, venues and promoters, but will also increase distribution of disabled artists' work (through digital means and touring up to an international level), affording greater opportunities for audiences to see the work. The funding is available both to individual disabled artists and organisations applying on behalf of disabled artists. The deadline for applications is 12noon on the 17th February 2014. 2. Big announces new "Power to Change" Programme (England)

The Big Lottery Fund has announced a new initiative which will invest up to £150 million to support the development of sustainable community-led enterprises across England. It will be delivered by an independent Trust from autumn 2014. The new initiative is a response to challenges that many communities are experiencing at the local level. The aim is to use the power of social enterprise to help more people respond to local need and opportunity, and change the places in which they live for the better. Eligible projects must be 'community-led', and the lead partner must be a charity, social enterprise, not-for-profit or member (co-operative) organisation. Tesco Charity Community Awards (UK)

Heritage Enterprise Programme (UK)

The Heritage Lottery Fund has announced that its £125 million Heritage Enterprise grants programme is open for applications. The scheme aims to support not-for-profit organisations to help them work in partnership with the private sector in the restoration of unused historic building and sites and unlock their economic potential. The programme is designed to address market failure, where historic buildings have failed to attract enough investment because the cost of their repair has not been commercially viable for private developers. Under the programme two types of grants are available:

- Grants of between £100,000 and under £2 million
- Grants of between £2million and £5million.

For grant requests of over £100,000 and under £2million decisions are made every three months. For grant requests of between £2 million and up to £5 million the next closing date for applications is the 7th February 2014.

Coastal Communities Fund (UK)

The Big Fund has announced that the third and final round of the Coastal Communities Fund (CCF) will open for applications in January 2014. The Coastal Communities Fund, which is financed through the Crown Estate's Marine activities, will provide grants in excess of £50,000 per project to support the economic development of a wide range of projects including those that support charities, the environment, education and health. Within the UK a total of £27 million is available. The fund is open to applications from a wide range of organisations including:

- Charities
- Voluntary and community sector organizations
- Social enterprises
- Local authorities
- Development agencies in Scotland, Wales and Northern Ireland
- Local enterprise partnerships in England
- Private sector companies.

Since the start of the CCF in 2012 the Big Fund has awarded grants to 62 organisations across the UK to the value of £32 million. Projects supported include a grant of £2 million to establish a national tourism academy in Bournemouth and a grant of £800,000 to expand the North York Moors heritage railway service. The deadlines for stage one applications during 2014 will be:

Welcome Trust Arts Awards (UK)

The Wellcome Trust is inviting organisations and individuals to apply for funding through its Arts Awards. The Arts Awards support projects that engage the public with biomedical science through the arts including dance, drama, performance arts, visual arts, music, film, craft, photography, creative writing or digital media. Applications are invited for projects of up to £30,000 through their small grants programme, and for projects above £30,000 through their large grant programme. The aim of the awards is to support arts projects that reach new audiences which may not traditionally be interested in science and provide new ways of thinking about the social, cultural and ethical issues around contemporary science. The scheme is open to a wide range of people including, among others, artists, scientists, curators, filmmakers, writers, producers, directors, academics, science communicators, teachers, arts workers and education officers. Welcome Trust People's Awards (UK)

Awards of up to £30,000 are available under the Wellcome Trust's "Peoples" Awards for projects that encourage public debate and understanding of biomedical science. Projects can include:

- Workshops and seminars; arts projects for a variety of different audiences and age groups
- Teaching materials or techniques to encourage wider discussions
- Projects that utilise the collections of the Wellcome Library and the Wellcome Collection at the Science Museum.

Funding can be for up to three years. Applications can be made by a wide variety of individuals, organisations and partnerships. The next applications deadline is the 31st January 2014. The Trust also makes "Society" Awards. These are grants in excess of £30,000. The next preliminary application deadline for "Society" Awards is 5pm on the 28 March 2014. Henry Smith's Charity Holiday Grants for Children (UK)

The Henry Smith's Charity has announced that it will start accepting applications through its Holiday Grant for Children Programme from the 1st November 2013 onwards. Applications can be made by schools, youth groups, not for profit organisations and charities for grants towards holidays or outings within the UK for children aged 13 and under who are from areas of high deprivation, are experiencing disadvantage, or those who have a disability. Applications can be considered for holidays or outings that have the objective of providing children with a break they would not otherwise have the opportunity to experience. The maximum grant available is £2,500 for any one trip. Grants are normally limited to a maximum of two-thirds of the total cost of a trip as we would expect some local partnership funding to be in place. Centre for Social Action Innovation Fund (UK)

The National Endowment for Science Technology and the Arts (NESTA) has announced that it is seeking applications through the Social Action Innovation Fund. This is a £14 million Fund to support the growth of innovations that mobilise people's energy and talents to help each other, working alongside public services. Through the programme, charities, social enterprises, public services and for-profit businesses can apply for grants of between £50,000 and £500,000. While applicants can be established in any part of the UK, the benefits of their proposals should focus primarily or significantly on England. The Innovation Fund will focus on a small number of big social challenges. The current priority is helping unemployed people improve their skills and get back to work, including through supporting enterprise and self-employment. Youth Music launches new funding programme (England)

Youth Music, the charity that sees to promote music making amongst children has announced that they are seeking to fund 10 projects across England comprising partnerships between schools and specialist music education providers. These partnerships (Exchanging Notes) will be funded to:

- Develop their music and education practice and activities to support young people at risk of low attainment, disengagement or exclusion from mainstream education to achieve the best musical, educational and wider outcomes
- To promote a collective understanding of high quality music education, stimulating fresh thinking in music and education practice.

Up to £30,000 per year (for up to four years) is available to projects that can demonstrate ambition and innovation in their approach. Each project must be a partnership between a school (or partnership of schools) and an external music organisation/provider. The lead applicant can be a school or another organisation. Arts Council England Strategic Touring Programme (England)

The Arts Council, England has announced that its Strategic Touring Programme has re-opened for applications. The £45 million Strategic touring programme aims to encourage collaboration between organisations, so more people across England experience and are inspired by the arts, particularly in places which rely on touring for much of their arts provision. The funding is available to both organisations and individuals. Partnerships, networks and consortia can also apply. These can include:

Promoters – Producers – Artists – Agencies – Companies - Marketing or audience development specialists - or / and local authority representatives or any other kind of organisation or individual. Creative Employment Programme (England)

The UK Government has announced that the next closing date for applications to the Creative Employment programme is the 10th January 2014. The £15 million, National Lottery funded programme is aimed at increasing work and training opportunities for unemployed young people. The programme will provide funding for 6,500 new traineeships, apprenticeships and paid internship opportunities to help young unemployed people aged 16 to 24 enter the arts and cultural workforce. Employment created will be in a wide range of disciplines, from technical to administrative roles, provided they are located in England and fall within the Arts Council England's footprint of:

Music – Dance – Theatre – Literature - Visual Arts - Contemporary Craft - Combined Arts – Carnival – Circus – Galleries – Museums - Libraries

The programme will provide part wage grants to employers who create new apprenticeship and internship job opportunities for young unemployed people aged 16-24.Read more at: http://creative-employment.co.uk/the-creative-employment-programme

The War Memorial Trust Grants Scheme (UK)

The War Memorials Trust has announced that its grants programme is open to applications for the protection and conservation of war memorials in the UK. The Trust currently runs a number of different grant schemes, which provide support to projects that aim to repair, conserve and preserve the war memorials in their existing form as well as reinstate the memorial in its original design. The Trust only offers grants to projects that relate to existing war memorials and not for the creation of new war memorials or projects for which work has already started and/or is completed. Film Enterprise Fund opens for applications (England excluding London)

Creative England has announced that its Film Enterprise Fund is open for applications. Through the fund, £2 million will be available over the next four years to improve the growth and sustainability of film-related businesses in England outside of Greater London. Creative England is looking to work with companies on an individual basis and design made-to-measure programmes of business support and funding to help entrepreneurs unlock new opportunities, develop creative strategies, refine their business models and attract increased levels of corporate finance. We are also looking to encourage new business alliances and joint ventures and to help companies enhance their capacity for international trade. Eligible companies can apply for either a Business Planning grant of up to £5,000 or for Business funding. There is no minimum or maximum level of business funding. Applicants are initially advised to submit an Expression of Interest form. There is no closing date and applications are accepted on a rolling basis. - 4. People's Postcode Trust Small Grants Programme (Scotland, Wales & N England)
 The People's Postcode Trust has announced that its small grants programme is due to re-open for applications from January 2014 and close on the 22nd February 2014. Through its small grants programme, the People's Postcode Trust offers grants of between £500 and £10,000 to small organisations and community groups for projects lasting up to 6 months in the areas of Poverty Prevention; Advancement of Health; Community Development; Public Sports; Human Rights; and Environmental Protection. Previous projects supported include:
 - Birkenhead YMCA which received a grant of £6,271 to set up a community garden project for homeless people;
 - and the Moray Art Centre which received a grant of £2,000 to run a play therapy group for children with autism.
