## **Elective Home Education**

Elective Home education (EHE) means the parent, carer or guardian of a child or young person has made an informed decision to home educate. This means off rolling their child or young person from the register of a school, or other education setting, to educate at home.

If you think EHE might be in the best interests of your child, and they don't have an Education, Health and Care Plan (EHCP) then you are able to write a letter to the school your child/young person attends and explain you are choosing to home educate. You do not need to inform the Local Authority (LA) as the school will have to do this; although it is helpful if you do. The LA is under no obligation to provide any special education provision to your child/young person should you decide to home educate.

If your child/young person does have an EHCP and they attend a mainstream school, then you should first write to the school your child / young person is

enrolled with and explain you intend to provide education at home. At the same time, you need to inform the LA and request they amend section I (educational setting), to reflect that they are receiving education at home. If the child / young person has an EHCP and attends a special school, you need to write to the LA to request the child/young person is removed from the school roll and once this is agreed the plan can be amended.

In the months following your decision the 'Services to Home Education' team from the LA will be in contact to meet with you, home visits are not legal requirements. If you feel it would be more appropriate you can meet elsewhere or have the conversation by telephone or email.

If you do choose to educate your child or young person at home, you will need to make your own educational arrangements.

If your child or young person has an EHCP, and you chose to EHE, the LA are no longer legally responsible to secure the Special educational provision (SEP) specified in the children, or young person's plan. The LA must ensure that the EHCP annual review continues yearly at a minimum, the LA also have a duty to make sure you are meeting the needs and provision identified in the EHCP.

Under Section 437 of the Education Act 1996, the LA must satisfy itself that parents/carers are fulfilling their duties regarding their child's education. If they feel this isn't happening, following an investigation, they may issue a School Attendance Order which is where your child/young person will have to go back to a school.

The Local Government Ombudsman has established (in its report Out of school...out of mind (LGO. 2011)) that the number of hours of teaching per week considered to represent full-time education is as follows:

- Reception and Key Stage 1 (R, Y1 and Y2) 21 hours
- Key Stage 2 (Y3 to Y6) 23.5 hours
- Key Stage 3 (Y7 to Y9) and Y10 24 hours
- Y11 25 hours

Before making a final decision to EHE, you may wish to investigate 'Education Otherwise than a school' (EOTAS).

EOTAS is used when no school setting is appropriate for a child/young person due to their special educational needs and disabilities (SEND) and so the LA can arrange for Special Educational Provision (SEP) to be delivered elsewhere other than a school college or early years setting. This means that it is the LA's responsibility to ensure the SEP is provided. This is still only acceptable for

Provision that 'Educate or trains' the child or young person.

If a child or young person will not be attending a school or institution at all and instead they will be receiving EOTAS, their EHCP should clearly describe their SEP in section F and section I should be left blank.

In either case EOTAS or EHE, must be suitable to the child's age, ability, aptitude, and SEN.
