SCHOOLS BUDGET QUESTIONS 2003/04

You will have been aware through the publicity over the past month of the school budget funding questions being posed by the DfES.

I felt I ought to clarify the situation for schools to avoid any confusion on the treatment of school funds in Norfolk.

The £10.7 million DfES suggest is being withheld from schools is made of three amounts. £2.8 million relates to Band E SEN funding and funding for NQT induction which will be released to schools in the next two terms as needs are identified. £6.3 million relates to Standards Fund resources which DfES guidance is being followed on its use and release. A full list of the £6.3 million is attached. The remaining £1.6 million is the additional DfES grant which was allocated to schools on 8 April.

A second point that is being made is that £4 million was being diverted from Norfolk schools, because the non-delegated element of schools block expenditure has grown more quickly than the delegated element. An example of this element of expenditure is nursery education which has indeed expanded rapidly and is set to continue to do so. In fact the DfES analysis also shows Norfolk passporting £10 million more than required

The third point is that DfES claims £3.4 million is being diverted from schools into capital spending. This sum is in fact Norfolk's contribution to the National Grid for Learning Spending which will be spent within schools once needs have been identified. It is classified as capital expenditure as a DfES requirement. I hope the above information clarifies that Norfolk is not withholding funds due to schools. The processes being used this year are identical to those employed in previous years.

I would add that I am very much aware of the budgetary situation facing all schools. I will be reporting the overall situation to local members later this month. I am also ensuring that local MP's including the Secretary of State are aware of the local school funding situation.
