- V4V and Seachange Arts would like to offer you the chance to exhibit your work as part of our community exhibition which runs from 5th March 2011 to 12th March 2011. The exhibition will act as a platform for local people to share their thoughts and memories of the regeneration of Great Yarmouth; the work of local young people will be shown alongside artists work, all of which relates to the theme of Re:generation.
- V4V is a youth volunteer led project which is supported locally by Seachange Arts. It is currently in its third and final year; the two previous years have seen successful projects

planned and executed by young volunteers. Striving to fulfil an identified community need, this year's team will be using the working title of Re:generation. Re:generation aims to provide local people of all ages the chance to share their experiences of the regeneration of Great Yarmouth. This includes work carried out during the post war years through to the ongoing regeneration work in the town. Our aim is to show a variety of works created by young residents of the town, combined with the recollections and stories provided by long standing members of the community. Re:generation volunteers, with the support of practising artists, will document these opinions and memories in what we hope will be both a thought provoking and creative way.

- As part of our exhibition which will celebrate the work produced by young volunteers, we intend to include relevant works by local artists. We are looking for work to show as part of an inclusive exhibition that will address the theme of Re:generation and include ideas of Great Yarmouth, its heritage and most importantly the regeneration of the town. We ask you to consider your body of work or any ideas you may have on these subjects and whether you would like to be part of an exciting and vibrant project such as this.

Jubilee People's Millions 2011

The Jubilee Peoples Millions is for those who have a great idea for a project to inspire their local community, involve local people working together to tackle a problem and need up to £60,000 to make it happen.

The Big Lottery Fund and ITV with the approval of Buckingham Palace will be helping mark the Queen's Diamond Jubilee. Through the Jubilee People's Millions BIG will be making 60 awards of up to £60,000 to new projects that will take place in 2012 and improve local places or the lives of people in the community. The public will vote on who gets the money, so the ideas need to capture the public's imagination and persuade them to vote.

The People's Millions has awarded over £25 million to 463 projects during the six years of the competition. A total of £3.6 million has been set aside for The Jubilee People's Millions competition.

Big Lottery Fund – Jubilee People's Millions

deadline: 4 February 2010

Community grants worth £60,000 are being made available to mark the Queen's Diamond Jubilee. The Big Lottery Fund is making the grants available in partnership with ITV, and with the approval of Buckingham Palace. The £60,000 Jubilee People's Millions awards are being made to go to new projects that will inspire or improve local communities.

Community groups across the UK are being invited to bid for a share of the £3.6m from the Big Lottery Fund good cause pot. Finalists will be showcased on ITV regional news when the public will invite and decide which projects receive the Lottery Diamond Jubilee funding.

Details of how to apply can be found on www.biglotteryfund.org.uk or by phoning 0845 10 20 30. Groups have until Friday 4 February 2011 to submit their entries.

Projects that receive the most votes will be awarded the funding next summer so they are up and running in time for 2012.

Media Trust Inspiring Voices

Showcase your community's fantastic use of digital media and you could win £500 and communications support through Media Trust's Inspiring Voices awards scheme. As part of its Community Voices project, Media Trust's Inspiring Voices awards seek to celebrate and encourage the varied and inspiring ways in which communities are empowering themselves through the use of digital media.

Media Trust is looking for ten examples of community digital media activities that could help inspire other communities to get going with digital themselves. The awards will be granted to the ten applicants deemed to have made the strongest case for their project.

To apply you'll need to create a profile and answer the following three questions:

- Does your community feel isolated, disadvantaged or voiceless? Please explain how.

- Can you demonstrate how this digital media work improves the lives of the people in your community? Please explain how.

uScreen Opens To Applications (South East)

Screen South is inviting legally constituted organisations operating in the South East to apply for grants of up to £7,500 through the UScreen Community & Exhibition Fund and grants of up to £3,000 through their Production & Workshop Fund. uScreen is part of the Legacy 2012 Accentuate Programme which seeks to change the way disabled people are seen by showcasing talent and developing film-making skills across the region. The uScreen Exhibition Fund is part of the uScreen Programme of activities and is funded by the UK Film Council Lottery Regional Investment Fund for England in partnership with the Legacy Trust and the South East England Development Agency (SEEDA). The fund aims to increase access to cultural films and learning opportunities in film, in particular for young people with disabilities. The Fund also aims to encourage critical engagement and understanding of film and to stimulate creativity for all audiences across the South East. Grants of up to £7,500 are available for exhibition projects, an element of partnership funding is essential.

Parks for People (UK)

The Heritage Lottery Fund (HLF) has announced that the next closing date for applications to the Parks for People programme is the 28th February 2011. Launched originally as a joint initiative with the Big Lottery Fund full responsibility for the programme has now passed to the Heritage Lottery Fund Local Authorities as well as not for profit organisations that own public parks and gardens can apply for grants of between £250,000 and £5 million for the regeneration of parks and public gardens (including squares, walks and promenades).

To be considered for funding, applicants need to show that the community values the park as part of their heritage; the parks meets local social, economic and environmental needs; and the park management actively involves local people.

Recent awards include a £1.84 million grant to restore Castle Park in Cheshire back to its original historic landscape and to improve sports facilities, the play area, and cafe and kiosk facilities and a £3.5million grant to restore the historic landscaping and buildings, upgrading footpaths, entrances, furniture and signage of Brockwell Park which is located between Brixton, Norwood and Dulwich.

Music Grants for Older People (England & Wales)

The registered charity, Concertina makes grants to charitable bodies which provide musical entertainment and related activities for the elderly. The charity is particular keen to support smaller organisations which might otherwise find it difficult to gain funding. Since its inception in 2004, it has made grants to a wide range of charitable organisations nationwide in England and Wales. These include funds to many care homes for the elderly to provide musical entertainment for their residents.

Some of the charities that have received grants from the charity include: Age Concern, Exmouth which received a grant for entertainments for the elderly in Exmouth and surrounding areas and Sue Ryder Care, Lancashire to fund access to music therapy workshops at Birchley Hall near Wigan and St Helen's.

BBC Children in Need Grants Scheme (UK)

BBC Children in Need are inviting not-for-profit organisations (including registered charities, voluntary organisations, schools, local authorities, churches, social enterprises, community interest groups, universities etc) working with disadvantaged children and young people 18 years and under, living in the UK, the Isle of Man or the Channel Islands, to apply for grants. BBC Children in Need run two grant schemes. Small Grants of £10,000 or less per year, for up to three years and Main Grants over £10,000 per year, for up to three years. BBC Children in Need can only fund projects that focus on the differences made (outcomes) to the lives of disadvantaged children and young people. BBC Children in Need aims to fund projects where a small amount can make a real contribution to the success of the project. Grants can be used to cover both, capital and revenue costs.

Examples of previously funded projects are: Free Form Arts Trust for a project that gave fun and creative holiday activity for disadvantaged children; Chance UK that provides mentoring and support to children with behavioural problems; and Kidscape that helps children who are disadvantaged through being severely bullied for an extended period.
