## Funding to Transfer Effective Practice in Teaching and Learning (England)

The Learning and Skills Improvement Service (LSIS) is inviting applications from eligible providers across the learning and skills sector through their Inspiring Practice, Improving Effectiveness Fund. ## Funding for Young People to Improve their Community (UK)

UK Youth, together with Starbucks, are rolling out a new programme called 'Youth Action' in major cities across the UK and Ireland. ## Youth Music announces changes to their funding programme (UK)

Youth Music has announced major changes to their funding programme due to the current economic climate. The new funding model will be structured around modules rather than programmes, enabling more flexibility and responsiveness. The majority of funds will be accessed via an open application process, and facilitate practice sharing and the development of a national community of providers. In June 2011, Youth Music will close their current Open Programme funding Stream, and will announce further details of the new funding model in July 2011, and launch the new model by September 2011. Youth Music will also host regional workshops in September 2011, to provide advice and guidance. The current Open Programme provides grants of £5,000 to £30,000 to support projects that provide music-making activities for children and young people in support of Youth Music's goals. ## **Music Grants for Older People (England & Wales)**
