#### Local communities and charities set for £700,000 a year boost

North Norfolk District Council's Big Society Fund, will allow communities within North Norfolk to benefit to the tune of almost £700,000 per annum and will begin awarding grants as soon as April next year. The aim of the fund will be to support projects that communities want and that will make a difference to the economic and social well-being of the area. The fund will be financed through the second homes council tax money that Norfolk County Council has agreed to return to NNDC.

Cllr Trevor Ivory, Cabinet Member for Localism and the Big Society and the driving force behind the idea said, "The Big Society Fund will be at the heart of our plans to put local communities back in charge of their own futures. It will help to reinvigorate our civic society and encourage local people to get involved with their communities.

"The Fund will be as flexible as possible so that it can support the ideas and priorities set at the town and parish level as well as being available for the bigger projects.

"We face tough economic conditions for sometime to come and that makes it even more important that the Council does everything it can to support local communities and charities. It is a real achievement to be making this investment at the same time as being able to freeze council tax for a further year."

#### Music hubs to drive music education from 2012

On behalf of the Department for Education, Arts Council England is investing more than £171 million of funding between August 2012 and March 2015 in a network of music education hubs across England. ACE will identify hubs through an open application process, which opened 25 November 2011. Music education hubs will ensure that every child aged 5-18 has the opportunity to sing and learn a musical instrument, as well as perform as part of an ensemble or choir. It will also allow young people to take their talent further - this might be through local ensembles, partnerships with nationally funded music organisations, including National portfolio organisations or through involvement in the Music and Dance Scheme.

Music education hubs will build on existing music services. A music education hub will be a collection of organisations working in a local area, to create joined up music education provision for children and young people, both in and out of school.

Hubs will be expected to form strong partnerships with local authorities, schools, music organisations, practitioners and communities to provide quality music education across the whole country - while delivering better value for money and greater accountability.

The assessment of applications will look closely at the following areas:

- leadership and governance
- a track record in high quality music education
- partnership working
- proposed music education hub delivery
