Big Society Fund

North Norfolk District Council's Big Society Fund offers town and parish councils in the District, along with voluntary and community organisations, the chance to apply for grants to support community projects intended to improve or support the wellbeing of communities and/or deliver improvements to the local economy in North Norfolk.

The Big Society Fund has a total of £450,000 available for the financial year 2012/13. Appropriate advice and guidance for organisations seeking to make applications is also available. The aim is for the grants to be easy to access for a wide range of community and charitable organisations and applications will be considered throughout the year.

The fund will be overseen by a cross-party board of District Council Members, while day-to-day administration will be undertaken on the council's behalf by the Norfolk Community Foundation, to whom all applications should be made. Applications are invited from 2 April 2012 and those submitted before 4 May 2012 will be considered at the first meeting of the Board on 21 May. Comic Relief Announces New Funding Round (UK)

Community Radio Fund (UK)

Telecom's Regulator Ofcom, has announced that the Community Radio Fund will open for applications on the 9th April 2012. Under the fund, Community Radio Stations can apply for funding to support their core running costs. These can include:

- Management costs
- · Administration, financial management & reporting costs
- Fundraising to support the station
- Community outreach work
- Costs involved in using volunteers.

There is no upper limit of grant that can be applied for. There is no upper limit of grant that can be applied for, however applicants are asked to take note of previous grants awarded for an indication of realistic award figures. Grants can only be made to community radio licensees who are broadcasting under a community radio licence (and not an RSL, for example). Funding To Support Poetry and Literature (UK)

The Clore Duffield Foundation has announced that the second funding round under its new £1 million programme to fund poetry and literature initiatives for children and young people across the UK is now open for applications. Through the programme, schools, FE colleges, community groups, libraries and other arts/cultural organisations can apply for grants of between £1,000 and £10,000 to support participatory learning projects and programmes focused on literature, poetry and creative writing for under 19s.

Projects that received funding under round 1 of the programme include Wisbech and Fenland Museum which received a grant of £6,000 to work with local arts organisation, Atelier East, to run a Young Poet Laureate contest to enliven, empower and engage young writers in the Fenland area. The programme is due to run from 2011 to 2015 with two funding rounds a year.

Music Grants for Older People (England & Wales)

The registered charity, Concertina makes grants to charitable bodies which provide musical entertainment and related activities for the elderly. The charity is particular keen to support smaller organisations which might otherwise find it difficult to gain funding. Since its inception in 2004, it has made grants to a wide range of charitable organisations nationwide in England and Wales. These include funds to many care homes for the elderly to provide musical entertainment for their residents.

Some of the charities that have received grants from the charity include Age Concern, Exmouth which received a grant for entertainments for the elderly in Exmouth and surrounding areas and Sue Ryder Care, Lancashire to fund access to music therapy workshops at Birchley Hall near Wigan and St Helen's. Funding for IT Projects Supporting Disadvantaged Groups (UK)

Funding is available to organisations with innovative IT related project ideas that can make a positive difference to disadvantaged and vulnerable groups - in the UK, developing countries and around the world. The funding is available through the Nominet Trust. The aim of the Trust is to fund innovative Internet projects that make a positive difference to the lives of disadvantaged and vulnerable people, primarily in terms of education, safety and inclusion. The Trust is particularly interested in funding projects that can be scaled up and replicated. There is no minimum grant application and applications for over £100,000 require an interview. Organisations wishing to apply need initially to complete and online eligibility questionnaire. Those organisations deemed successful will be provided with a link to a more detailed application form.

Previously projects supported through the Trust include:

- Pottery Primary School, Belper, which received funding towards the costs of printed material to raise awareness to parents, children and the community of internet risks and safety measures.
- Age UK, a new charity dedicated to improving the lives of older people which received funding from the Trust to promote digital inclusion of older people in nursing homes.

Coastal Communities Fund

 The £23.7 million Coastal Communities Fund (CCF) is supporting the development of coastal areas, promoting sustainable economic growth and jobs, so that people are better able to respond to changing economic needs and opportunities.

Individual bids will be invited from £50,000 upwards. There is no set upper limit on grants; however, the Big Fund has suggested that the maximum amount awarded is unlikely to be greater than £2 million in those countries with an overall allocation greater than £2 million (England and Scotland). The funds can be used to support both capital and revenue projects and communities will be encouraged to match funds with other pots of money.

Examples of activities that may be eligible for funding include:

- supporting skills and training initiatives to improve job prospects;
- maintaining and developing specialised tourist infrastructure;
- managing and adapting to flood and coastal erosion risk;
- supporting social enterprises to bring new economic opportunities and jobs;
- offering apprenticeships to school leavers;
- creating new workspaces to support and grow local economies;
- boosting local approaches to promoting enterprise and economic regeneration;
- supporting sustainable transport improvements.

Innovative bids will be welcomed from businesses, social enterprises, local enterprise partnerships, charities, voluntary groups and local authorities supporting economic development within the community.

Applications must be received by 25 March 2012 (early deadline in England and Wales) and 27 April 2012 (main deadline in England, Scotland and Northern Ireland).

Funding for Young People to Explore their Heritage (UK)

Young Roots offers grants of between £3,000 and £50,000. The scheme aims to involve 11 - 25 year-olds in finding out about their heritage, developing skills, building confidence and promoting community involvement. Projects need to be related to the heritage of the UK. For example, it could involve young people researching a local archive or doing practical casework on a nature reserve. Projects must also show how young people are managing and participating in the project.

Previous projects supported include:

Parks for People (UK)

The Heritage Lottery Fund (HLF) has announced that the next closing date for applications to the Parks for People programme is 31st August 2012. Launched originally as a joint initiative with the Big Lottery Fund full responsibility for the programme has now passed to the Heritage Lottery Fund Local Authorities as well as not for profit organisations that own public parks and gardens can apply for grants of between £250,000 and £5 million for the regeneration of parks and public gardens (including squares, walks and promenades). To be considered for funding, applicants need to show that:

- The community values the park as part of their heritage.
- The parks meet local social, economic and environmental needs.
- The park management actively involves local people.

Recent awards include:

- A £1.84 million grant to restore Castle Park in Cheshire back to its original historic landscape and to improve sports facilities, the play area, and cafe and kiosk facilities.
- A £3.5million grant to restore the historic landscaping and buildings, upgrading footpaths, entrances, furniture and signage of Brockwell Park which is located between Brixton, Norwood and Dulwich.

The Ford Britain Trust has announced that its grant programme is currently open for applications. The Trust provides grants for the advancement of education and other charitable purposes beneficial to those areas where the Ford Motor Company Limited has its present activities and a long standing association with local communities. Department for Education Launches £50 Million Summer Schools Fund (England)

The Department for Education has announced its £50 million Summer Schools Fund to help support up to 100,000 pupils making the transition from primary to secondary school is open for applications. This transitional period has been identified by Ofsted research as a time where performance can take a significant dip. Secondary schools can apply for up for £500 for every disadvantaged pupil taking part in a two-week summer school. The funding applies to all pupils transferring in to Year 7 who are on:

- Free School Meals
- Have been looked after in public care continuously for six months. Schools will be free to ask third parties, such as voluntary groups, to run the summer schools for them or work together with other schools. Examples of activities that the funding could be used for includes:
 - Transitional activities such as meeting teachers
 - Having a tour of the school or learning more about their new curriculum
 - To build on schools' own induction arrangements.

This will help pupils familiarise themselves with their new environment and give them a flying start. Funding will be paid in two parts - in June and September 2012:

- for maintained schools paid via the Local Authority
- for Academies and non-maintained special schools paid directly

The Government has announced that the next funding round of the Regional Growth Fund is now open to applications. The Regional Growth Fund is a discretionary £1.4bn Fund that will operate for 3 years between 2011 and 2014 to stimulate enterprise by providing support for projects and programmes with significant potential for creating long term private sector led economic growth and employment. In particular it will help those areas and communities that are currently dependent on the public sector make the transition to sustainable private sector-led growth and prosperity. This can include:

- A combination of large private sector players

Successful applicants during the last bidding round include Nifco UK in Stockton on Tees in the North East, which will use £1.65 million of RGF support towards an £11 million project to equip a new factory and help the company move into the market for electric vehicle batteries. This is expected to create 128 new jobs and safeguard 158 current jobs and e2v Technologies Limited in Chelmsford, Essex, will use £6.25 million of RGF support to boost its work developing microwave processing systems for a range of industrial applications in resource
