#### **Chamber Music in the Marble Hall at Holkham with Kungsbacka Piano Trio** June 8<sup>th</sup> at 7pm

Beethoven: "Kakadu" Variations Op.121 Beethoven: Piano Trio Op.1 No.1 Tchaikovsky: Piano Trio in A minor Op.50 Formed in 1997 and named after the Swedish town where it gave its first performance, the Kungsbacka Piano Trio won first prize in the prestigious Melbourne International Chamber Music Competition in 1999. They perform regularly at major concert venues around the world and this season will play at Wigmore Hall and at the Mecklenburg-Vorpommern Festival. The trio's first recording was of Schubert on the NAXOS label and was released in 2006 to critical acclaim. Since then the trio has recorded Mozart's complete works for piano trio and piano trios by Haydn. Each member of the trio also teaches at The School of Music at Gothenburg University. The Kungsbacka's programme begins with two piano trios of Ludwig van Beethoven. First we are to hear the early "Kakadu" Variations and then Op.1 No.1, the dynamic trio in E flat. The Beethoven trios are well contrasted by Tchaikovsky's chamber music masterpiece, the majestic yet deeply personal Piano Trio in A minor.

#### Arts Council - Strategic Touring Programme (England)

The Arts Council, England has announced the winners of the first funding round of its Strategic Touring Programme. The £45 million Strategic touring programme aims to encourage collaboration between organisations, so more people across England experience and are inspired by the arts, particularly in places which rely on touring for much of their arts provision. The funding is available to both organisations and individuals. Partnerships, networks and consortia can also apply. These can include promoters, producers, artists, agencies, companies, marketing or audience development specialists, local authority representatives or any other kind of organisation or individual. Grants need to be more than £10,000 per project.

#### Enhancing Communities Programme (UK)

#### Heritage Grants over £1 Million (UK)

Under the Heritage Grants scheme funding is available for projects that relate to the national, regional or local heritage of the UK. To be eligible for funding a project must:

- Help people to learn about their own and other peoples heritage
- Conserve the UK's diverse heritage for present and future generations to experience and enjoy
- Help more people, and a wider range of people, to take an active part in and make decisions about heritage.

HLF welcome applications from single organisations and partnerships. Priority is given to not-for-profit organisations, and partnerships led by not-for-profit organisations. If private owners are involved, HLF expect the public benefit to be greater than any private gain. In addition, the HLF also makes grants of £50,001 - £1 million; and Grants in excess of £5 million. #### Church and Community Fund Announces New Funding Themes (England)

Following a review of its funding activities, the Church of England's Church and Community Fund has announced that it is now accepting applications under its new strategic funding schemes. The overall aim of the fund is to grow the Church of England and develop its capacity to engage with the whole community. Through the new funding themes, community projects run by parish churches, deaneries, dioceses and other bodies connected to or working in partnership with the Church of England can apply for funding for projects that significantly expand the Church's engagement with neighbourhood renewal; seek innovative ways of developing established community projects so that they either grow existing or evolve into new communities of Christian Faith, and; replicate models of successful community engagement across the wider church. The level of grants available range from £10,000 to £20,000; except for the theme relating to the replication of projects where grants are in excess of £20,000. #### Grants to Help New, Innovative Visual Arts Projects (UK)

The Elephant Trust offers grants to artists and institutions (priority is given to small organisations and galleries) for new, innovative visual arts projects based in the UK. The Trust's aim is to make it possible for artists and those presenting their work to undertake and complete projects when confronted by lack of funds. The Trust supports projects that develop and improve the knowledge,

understanding and appreciation of the fine arts. Priority is now being given to artists and small organisations and galleries who should submit well argued, imaginative proposals for making or producing new work or exhibitions. Arts Festivals are not supported. The Trust normally awards grants of up to £2,000, but larger grants may be considered.

#### The Sylvia Waddilove Foundation (UK)

The Sylvia Waddilove Foundation provides grants to charities for educational projects, music composition and performances, herbal medicine, medical research, disability, and farming related projects. Grants of up to £20,000 are available to registered charities with a turnover of less than £500,000. The Foundation favours supporting small charities that will carry out the project themselves (except in the case of medical research), who rely on volunteers and who can demonstrate a successful history of projects.

#### New Grants Available for Community Music (UK)

The BBC Performing Arts Fund has announced that its Community Music scheme is open for applications. From hip hop to samba, classical to jazz, the Community Music scheme aims to help not for profit community music groups in the UK to carry out training, attract new audiences, encourage new members and raise their profile in their community. For e.g. the funding could be used to:

- Send key members of a Group on a training course
- Run workshops with the intention of encouraging and attracting new participants to join in
- Engage experts to provide master classes to improve the overall standard of the Group's performances
- Provide a facilitator to run a workshop in which the Group collaborates with schools or other local community groups
- Create a performance partnership with another Group in the Group's community, e.g. a music group or a school; etc.

Community groups looking to apply for a grant as part of the scheme can either apply for up to £5,000 for a development project (Option 1) OR up to £10,000 for a project that includes the commission of a new piece of music (Option 2). Applications for the scheme will close either at 5pm on 29th June 2012 OR when we have received the first 500 eligible applications, whichever is the soonest. #### Architectural Heritage Fund (UK)

The Architectural Heritage Fund (AHF) is a registered charity that promotes the conservation and regeneration of historic buildings in the UK. Grants and low

interest loans are available to voluntary organisations and building preservation trusts (BPTs) to regenerate historic buildings. The aim is to create community and education facilities, workspace and homes. To be eligible to apply for financial assistance organisations must have a charitable status. Any charity with a qualifying project can apply for an options appraisal grant, or a loan, but any other AHF's grants are reserved for BPTs - charities established specially to preserve historic buildings. The project must also involve a change of ownership and/or a change of use.

Previously funded projects include:

- Turning a rundown historic buildings into; Community theatres
- Resource centres; Community learning centres
- Workspaces
- Places to live; and Community meeting places, etc.

#### Co-op Community Membership Community Fund (England & Wales)

The Community Membership Fund uses the "odd pence" donated from Cooperative Group Dividend cardholders to fund projects that benefit local communities. Community and voluntary groups as well as charities can apply for funding of between £100 and £2,000 to support projects that benefit the local community. To be eligible, the project must benefit a local community in which at least one Co-operative group business trades. The activities supported must fulfil a need in the local community such as combating crime and anti-social behaviour, promoting education and improving health. Activities must also target disadvantaged groups or areas and be in line with co-operative values and principals. Past projects include:

- Concorde Wheelchairs Dancers a Bristol dance team with members representing all ages and disabilities. The Co-operative Membership Community Fund awarded the group a grant of £500, enabling members to take part in a national competition in Blackpool.
- Blaina After School Club based at Ystruth Primary School which provides care for autistic children and their siblings. The school club has recently received a donation of £500 from The Co-operative Community Fund, and has used the money to create a sensory garden.

#### Young Roots (UK)

Young Roots offers grants of between £3,000 and £50,000. The scheme aims to involve 11 - 25 year-olds in finding out about their heritage, developing skills, building confidence and promoting community involvement. Projects needs to be related to the heritage of the UK. For example, it could involve young people researching a local archive or doing practical casework on a nature reserve. Projects must also show how young people are managing and participating in the project. Previous projects supported include:

- Kirkby Stephen Grammer School which received a grant of £15,300 to produce a film about the construction of the Settle-Carlisle Railway which is an important part of the heritage of their area.
- Villa Real School was awarded a grant of £19,875 to work in partnership with a local museum to explore and gain firsthand experience in ancient crafts.

The types of activities that can be supported include:

- Visits to places like historic buildings, landscapes, parks, burial grounds, museums, archaeological sites or industrial heritage sites like railways
- Using collections like archives, libraries and museums, including collections held by people in the community
- Talking to people who know about heritage or holding workshops, talks and sessions exploring people's memories
- Recording things like people's memories or local wildlife
- Scanning old photographs and documents
- Archaeological digs or surveying historic buildings.

To be eligible for funding organisations will need to:

- Share what has been learnt by holding or producing things like Community events
- Digital things like smart phone apps, DVDs or websites
- Display boards
- Exhibitions
- Guides/trails
- Leaflets or books
- Packs for schools
- Performances.
