New Funding for Rural Communities (UK)

Rural communities across the UK are set to benefit from a fund to help them revive their villages through community enterprise. The Plunkett Foundation has been awarded over £450,000 from the Esmée Fairbairn Foundation to create a new comprehensive support service for rural communities considering setting up or diversifying community-owned services like shops and pubs. The support service will provide a combination of adviser support, training, feasibility grants, and opportunities for networking with other community enterprises. The support is specifically focused at the early stage of a community's ideas, and will help them progress to the next stage. Eligibility for support will depend on communities aiming to raise at least £10,000 themselves through community shares and support will be given to ensure communities are creating viable and sustainable businesses that engage the whole community.

Connecting Classrooms Partnership Grants (UK)

The British Council has announced that schools involved in an existing partnership between the UK and another country with are being invited to apply for further funding to the Connecting Classrooms programme. The programme provides support to develop joint curriculum projects and partnerships with schools in Asia and Africa. Connecting Classrooms offers grants to cover project-related costs. Grants of up to £1,500 per school involved in the partnership are available. The grant must be spent on reciprocal partnership visits. If the entire grant is not spent, the remainder can be used for project resources and communication costs. To apply for funding, schools will need to evaluate their existing partnership and show they will progress over the next year. Once schools have completed a year of activity, they will be able to apply for funding for another year. Partnerships must demonstrate progression to receive funding again.

The Sylvia Waddilove Foundation (UK)

The Sylvia Waddilove Foundation provides grants to charities for education projects (organic farming, animal husbandry, veterinary science, animal welfare and animal surgery) the visual and performing arts; the preservation of buildings of architectural or historical significance; the accommodation of those in need; the skills based training of young people; medical research and disability. Grants of up to £25,000 are available to registered charities. The Foundation favours supporting small charities that will carry out the project themselves (except in the case of medical research), who rely on volunteers and who can demonstrate a successful history of projects.

Esmée Fairbairn Collections Fund (UK)

The Museums Association (MA) has announced that the next application deadline for funding through the Esmée Fairbairn Collections Fund is the 5th April 2013. The fund focuses on supporting time-limited collections work outside the scope of an organisation's core resources. Through this fund the MA will award approximately £800,000 per year to museums, galleries and heritage organisations with two grant rounds per year. Projects that are eligible to apply to the Esmée Fairbairn Collections Fund include:

- Research into collections
- Conservation
- Collections review
- Initiatives to develop the use of collections.

Previous projects supported through the fund include:

- The Horniman Museum and Gardens, which received a grant of £50,450 to review the museum's natural history collections.
- The People's History Museum which received a grant of £47,033 for a partnership project to digitally link collections across the museum, the Labour History Archive and Working Class Movement Library.

Fulbright Teachers Exchange Programme's Deadline Extended (UK)

The British Council has announced that Teachers within the UK that would like the opportunity to trade places with an American teacher either for an autumn term or a whole academic year have the opportunity to apply to the Fulbright Teachers Exchange Programme. Exchanges involve elementary and secondary schools, including kindergarten and community colleges throughout the United States. For UK applicants the programme covers all levels from primary to further education and to be eligible for support, the applicant must be a qualified teacher or equivalent, with five years full-time teaching experience in the UK. Two of these years must be in the institution from which the exchange will take place. The costs of transport for the exchange are covered by the programme and participants will continue to be paid by their employer while on the exchange. New Grant for Preventive Conservation of Collections (UK)

The Association of Independent Museums (AIM) has announced that it has developed a second conservation funding strand to its Conservation Grant Scheme. The scheme has been set up to help small museums develop a more sustainable approach to the conservation and management of collections through improvements to preventive conservation within their museum. Bids will typically be small interventions, more passive and simple methods of environmental control, low energy, low carbon, no air-conditioning and methods that can be easily maintained by non-technical staff and volunteers. Priority will be given to obtaining professional advice in compiling conservation and implementation strategies, and training for volunteers. Eligible AIM members must be registered or accredited, or expect to achieve accreditation within two years, and they must have fewer than 60,000 visitors or a turnover of less than £300,000 per year. Maximum grant will be £10,000 and average grants awarded will be around £5,000.

Young Persons Volunteering Fund (England, Scotland & Wales)

The Sita Trust has announced that the final funding round of its Young Person's Volunteering Fund will close at 5pm on the 2nd January 2013. Through this fund, the SITA Trust can provide grants of up to £10,000 for volunteering projects owned by 14-25 year olds. This fund has been created to assist young people aged 14-25 to volunteer their time to create or enhance facilities that can be enjoyed by the wider community. SITA Trust can for example, provide funding towards the resources required by young volunteers to transform a derelict piece of land into a community green space or give a local community centre a much needed 'make-over'. Music Grants for Older People (England & Wales)

Skills for the Future Programme Re-opens for Applications (UK)

The Heritage Lottery Fund (HLF) has announced that its £15 million "Skills for the Future" programme has re-opened for applications. Skills for the Future funds work-based training in a wide range of skills that are needed to look after buildings, landscapes, habitats, species, and museum and archive collections, as well as equipping people to lead education and outreach programmes, manage volunteers and use new technology. The HLF give grants to not for profit organisations that can demonstrate a skills shortage and are able to plan and develop a new training programme and to recruit, train and pay trainees new to the sector. You can apply for a grant from £100,000 to £1million. Skills for the Future applications go through a two-round process. Applicants must submit their first-round application by 12 noon, 31 January 2013. Applicants successful at this stage will then need to submit a detailed training plan. vInspired Cashpoint is offering funding of up to \pounds 500 to young people (14 – 25 year olds) who want to set up a local project to help their community. To be eligible for funding, the project should be of benefit to the community where the young people live, or where they spend most of their time, or a group of people that they would like to help. The project should be a new idea or something that applicants have tried before but would like to do differently. Grants need to be used within two months of the project start date and should create a least two more volunteering opportunities for 14-25 year olds (in addition to the applicant).

Wellcome Trust: Society Awards (UK)

The Wellcome Trust has announced it is seeking applications through its Society Awards. Society Awards can fund the scaling-up of successfully piloted projects (whether funded through People Awards or through other means) or can fund projects that are more ambitious in scale and impact than is possible through a People Award. Society Award-funded projects would normally expect to reach audiences with a wide geographical spread across the UK and/or Republic of Ireland. They can also part-fund larger projects.
