### **Background**

Under the Health and Social Care Act 2012, the Government requires each local authority that provides social care to put in place a local Healthwatch. The role of these new, independent organisations is to improve the involvement and influence of local people who use social care and health services and their carers so as to:

- Improve the quality of social care and health services
- Improve access to information about social care and health services
- Influence strategies and the commissioning of social care and health services.

Local Healthwatches will be able to refer serious issues to Healthwatch England, a new national body.

### What has happened so far in Norfolk?

Ten consultation events have been held around the county to get people's views about the priorities for Healthwatch Norfolk and about how it should deliver them.

A Shadow Board has been set up to lead the development of Healthwatch Norfolk in preparation for it becoming operational on 1 April 2013. The Healthwatch Norfolk Shadow Board comprises 4 community members (representatives of small organisations and individuals), 4 organisation members (organisations that will form the consortium that will deliver the work), 4 co-opted members (brought in to ensure that the board members among them have all the skills necessary to develop Healthwatch Norfolk) and an interim, independent chair.

Healthwatch Norfolk has been formally registered as a Company Limited by guarantee and is in the process of seeking charitable status.

Healthwatch Norfolk is in the process of appointing a Chief Executive and is currently advertising for a permanent independent chair.

Norfolk RCC has been contracted to develop the membership of Healthwatch Norfolk and manage the initial board elections to ensure Healthwatch Norfolk can be as effective as possible from day 1.
