NATIONAL SURVEY OF SCHOOLS' VIEWS OF THEIR LEA, 2003

The survey will be open during the seven weeks from: 19th May to 7th July 2003.

However, this simple survey allows all of us to see how those responses compare with those of High schools elsewhere. It also provides a basis for ongoing annual surveys using standard questions so that we can all see how the perception of services changes over time.
