Message from the Interim Assistant Director, Early Help Michael Rosen

Norfolk County Council agreed to the task set by central government to turn around the lives of 1700 families by May 2015. As the Troubled Families Initiative enters the final year of its three year programme, **Norfolk has "turned around" 337 families.**

34% of families worked with in Norfolk, have taken charge of their lives and committed to lasting change.

Children Services Leadership Team is committed to achieving the target set by central government, and recognises the continued partnership work required in order to achieve the targets.

Norfolk Family Focus (NFF) Workforce increased by 50%.

NFF and partners are working together to identify families by June 2014 to support them to take charge of their lives and commit to last change by May 2015.

Norfolk is on track to identify all 1700 families by the end of June 2014.

Louise Casey CB Director General, Troubled Families visited Norfolk on the 3 April due to concerns expressed about Norfolk's approach to the troubled families programme. After meeting front line practitioners, the NFF Programme Team and senior managers, Louise Casey left saying "Norfolk is back on track". Thanks to all involved!

East of England Project

On the 18 November 2013, Norfolk County Council in partnership with Gt Yarmouth Borough Council successfully secured funding through the East of England Local Government Association, to enhance the Norfolk Family Story Board and deliver Community Connectors in Gt Yarmouth.

Gt Yarmouth Borough Council has appointed 3 Community Connectors.

Norfolk County Council is working in partnership with Hewlett Packard to deliver an electronic Self Help tool through the use of the Family Story Board.

Stonham Family Intervention Project (FIP) Update


Stonham secured the FIP contract as of the 1 April 2014 for rural Norfolk. Following a restructure Stonham has appointed 8 frontline colleagues and has 7 vacancies still to fill, these will be advertised within the next few weeks on http://sector1.net.

Stonham is working with an existing caseload and accepting new referrals. Stonham is really excited about the new service and the joint working opportunities. Stonham will be co-located with Norfolk Family Focus colleagues (with the exception of King's Lynn, where Stonham is based at King's Lynn Borough Council within the operational partnership team) and look forward to developing these relationships for the benefit of children, young people their parents/carers in rural Norfolk.

May Data Returned - Deadline 13 June 2014

Following recent audits by the Department of Communities and Local Governance and Norfolk Audit Services, lessons have been learnt regarding how we evidence supporting data.

The NFF Programme Team will transfer all the old data into the new format and returned by the 30 May.
