FIT is a partnership between The One account, City College, WEETU (Women's Enterprise Employment and Training Unit) and the Financial Industry Group. It is aimed at attracting and fully preparing adult returners to join the financial industry by providing enhanced training through the partnership free of charge.



## A step back in time



This month's 200th edition of Moneyfacts has focused our minds on quite how much our financial services market has altered in the last 17 years.

We have seen some dramatic changes since Moneyfact's first issue in November 1988. The publication has expanded in order to keep up with the new trends, which has resulted in a twentyfold increase from six pages in 1988 to the current 120! The original issue included mortgages, credit cards and investment accounts, showing both annual and monthly interest and regular savings accounts. It also managed to fit in chequebook accounts - all 25 that existed then and also the four unsecured personal loans that were available at the time.

The range of products we now cover has expanded drastically. Institutions in 1988 offered a choice of notice or no notice savings accounts. It is now not unusual for an institution to offer four or five standard accounts, plus the extras such as Child Trust Funds, Cash & TESSA-only ISAs, not forgetting offshore accounts in several currencies. The mortgage market has also grown not only in size but also in diversity. In 1988 institutions offered only their standard variable rate. The full list of providers used to take up one page; now we have over 35 pages (and the font is a lot smaller!). Those with less than perfect credit ratings have also found themselves able to buy with the assistance of the flourishing credit impaired market.

Even areas such as personal finance have been through an overhaul. The original chequebook accounts now come in various forms; the provision of credit cards has also become a growth area, expanding from 19 providers to over 60. We are sure that the markets will continue to grow as each provider tries to find its niche market. We look forward to the 250th Issue.

## Call for stronger industry regulation

In a rare step for a financial company, a local industry leader is calling for more regulation to protect consumers from quick-fix investment businesses.

Mark Alexander is Managing Director of The Money Centre, one of the biggest providers of buy-to-let mortgages in the UK which is setting records by handling over £125 million of mortgage applications a month. He was commenting in the wake of recent reports of six buy-to-let firms being taken to court by the DTI for so-called get rich quick property schemes.

"There are several buy-to-let companies in the industry which are continuing to damage the reputation of the market as a whole", said Mark. "The recent bad press is scaring investors from entering the market and damaging the image of the many reputable companies which operate entirely ethically.

"More and more people are aware of and so are attracted to companies promising easy ways of

entering the market and making a quick fortune. These companies are taking advantage of naive investors and are not making people fully aware of the commitment and risks involved. I am pleased to hear these businesses have been put

under the spotlight for damaging the reputation of the industry as a whole and creating mistrust among potential investors. I am wholly supportive of the calls for the Government and the Financial Services Authority to expose such companies and for tighter guidelines to be put in place to rid the market of buy-to-let 'cowboys'. We want to see the market's reputation fully restored and ensure new investors are placing their personal finances in the hands of people they can trust."

Mark has always been a strong advocate of proper controls and he and Director Mike Woodfine were, more than a decade ago, founder members of the National Association of Commercial Finance Brokers, the industry body that supports high professional standards in sourcing commercial funding through a



Senior Communications Manager Jason Wyer-Smith has won the 'Pensions and Investments Professionals' category of the Financial Times and AXA UK Pensions Manifesto Challenge.
