The County has been working closely with QCA and the Association for Physical Education (afPE) to ensure that it can support the development of the new curriculum for Physical Education across Norfolk.

As you will be aware this is to start 2008 with the year 7 cohort and to be fully implemented by 2011. These changes are a great opportunity to engage with the process of reviewing how your curriculum meets the needs of your young people and addresses the move from content driven to a process approach. There will also be the opportunity to reflect upon the data collected through Children's Services and Active Norfolk with regard to the types of activities young people want to engage in.

Schools are actively encouraged to engage with the process of review and will be challenged to do so through the workshop.
