Review Of School Organisation

I suspect that you will have read, in the local press, of the progress being made on the Norfolk Schools PFI project. You will be aware that the date for implementation of the review does depend on the timescale for the PFI project. Jarvis have now been appointed as preferred bidder. This means that detailed negotiations can proceed and that the timescale for review has become firmer. I anticipate that the PFI contract will be signed around the end of March 2004.

You will remember that the date for implementation of the review was stated in the public notices as being September 2004. It was a requirement of the drafting of the public notices to quote a firm date. However it was made clear in the notes accompanying the notice that a later date for implementation was likely in much of the review area. In order that there is certainty about the date on which reorganisation can take place, I will need to wait until the contract is signed before taking the necessary action to amend the date of implementation. This will require the School Organisation Committee to agree to change the date. However the bid from Jarvis for the PFI project indicates that the likely implementation dates for each of the secondary school areas are as follows:

September 2005 Loddon Long Stratton

September 2006

Gt. Yarmouth Gorleston Caister Martham Stalham Swaffham
