SEN Caseworker allocation to schools in Central Area

Please find attached a list of the SEN Caseworkers allocated to schools and parents of pupils undergoing Statutory Assessment and holding statements in Localities 6, 7 and 8 from September 2007.

Changes have been made as a result of the move towards locality working and due to the restructuring of Children's Services. Diana Jones (full-time) and Diane Davis (part-time) have been appointed Senior Caseworkers with team leader responsibilities in addition to their caseworker roles.

Administrative support will continue to be made via Brenda Fuller (224010) and Dinah Rosembert (224015).

In total there are 3 full-time equivalent caseworker posts in Central. Within this, some caseworkers work part-time. We aim to provide cover in the office across most of the school week; however, we are often working in schools and other locations. If we are unable to answer your query straight away, please leave a message and we will endeavour to get back to you as soon as possible.

In 2007/2008 we will have to continue prioritising some of our work. This includes limiting our attendance at annual statement review meetings, only attending where there are significant issues, or for some of the 'phase transfer' reviews in Year 5 or Year 1.

Unfortunately we are also currently unable to routinely amend all statements where amendments are requested at annual review. We are prioritising those for phase transfer, where there is a change of school, or a new diagnosis. We would still be pleased to receive suggested amendments, but may need to carry them forward to, for example, a statement which is amended for phase transfer.

Our top priorities are first statements and working to ensure that children with statements have a school place.
