Description

Young people and alcohol seem to be rarely out of the news and, while there has been an overall fall in the proportion of young people drinking, there has been a sharp increase in the alcohol consumption of young people who do drink. The consequences for individuals are well-documented, with wider implications for society in terms of linkages to offending, violence, use of other drugs, absence from school and risky sexual behaviour.

The Government's Youth Alcohol Action Plan, recently published, focuses on five priorities: enforcement activity to address young people drinking in public places; action with industry on young people and alcohol; developing a national consensus on young people and drinking; establishing a new partnership with parents on teenage drinking; and supporting young people to make sensible decisions about alcohol. In particular, its ambition is to effect a 'culture change' regarding alcohol and young people.

In tackling these issues, local authorities and their strategic partners have a clear role to play, which this seminar will explore. It should be relevant not only to those directly concerned with substance misuse issues, but also anyone with an interest in the consequences of alcohol abuse for children and families.
