## Artists taking the lead

Arts Council England and London 2012 announced on 22 October that Pacitti Company's 'On Landguard Point' has been selected as the East of England winner of a £500,000 commission for Artists taking the lead, one of the major projects for the London 2012 Cultural Olympiad.

Suffolk-based artist Robert Pacitti's winning idea is a mass public research around notions of home. A feature film, starring members of the local community alongside leading artists, will be created from a series of spectacular large scale participatory outdoor events. The events will take place across the region and explore key themes of trade, defence and migration.

The aim of the fund is to commission new work that is artistically led by disabled people. Grants of between £25,000 and £50,000 are available to disabled and Deaf artists, and disabled and Deaf-led arts organisations, who wish to develop their work, strengthen their artistic practice, challenge perceptions and forge new partnerships with presenting venues and events.

#### Funding to Promote European Partnerships between Schools (UK)

The European Commission has announced that its Comenius Programme is now open for applications. Comenius is part of the EU's Lifelong Learning Programme and is aimed at

schools, colleges and local authorities across Europe. The aim of the programme is to develop knowledge and understanding among young people and education staff of the diversity of European cultures and languages, and the value of this diversity and to help young people to acquire basic life skills and competences for their personal development, for future employment and for active European citizenship. Grants are available for:

- projects that bring together pupils, teachers and other staff collaborating with partner schools and colleges in Europe
- professional development of education staff in another European country
- trainee teacher placements in schools and colleges across Europe
- Local Authorities across Europe working together
- partnership meetings
- large scale partnerships and networks to develop staff competencies and to exchange experience and best practice.

#### **Community Cash Awards (UK)**

Young people are being given the chance to claim a share of £1 million to help tackle the dangers of drugs, crime and play a positive role in their community.

The Royal Bank of Scotland Community Cash Awards will see £1 million of grants being distributed by youth charity "The Prince's Trust" to young people who want to run community projects in some of Britain's poorest areas. The Awards, worth £250 to £5,000, are available to disadvantaged 14 to 25-year-olds who want to transform their area and learn practical skills. Projects could range from improving local youth facilities to sex education workshops in schools.

Projects must:

- be run and managed by people between the ages of 14 and 25
- clearly benefit the local community
- benefit the people running the project
- be a new or developing project.

# Funding For Arts Organisations Producing and Presenting Arts Made By Older People (UK)

The Baring Foundation has announced that its Arts Programme is now open for applications. This year, the theme of the Baring Foundation's Arts Programme is to support arts organisations in the UK already producing and presenting arts made by older people. In particular, the Baring Foundation wants to support arts organisations which specialise in or have a very strong record of practice in enabling older people to:

- Participate in a creative capacity, not simply as observers or audience members
- Participate in arts activities which seek to foster intergenerational understanding and co-operation
- Have a genuine voice in relation to the choices offered by arts organisations and other agencies.

To be eligible for funding applicants need to be a constituted not for profit organisation with an annual income of at least £50,000 and have already undertaken high quality work led by or involving older people. #### Funding for Individual and Small Groups to Improve their Local Communities (UK)

Groups of individuals as well as small community and voluntary groups within the UK that want to improve their communities can apply for funding through the Wakeham Trust. The Trust are particularly interested in supporting neighbourhood projects, community arts projects, projects involving community service by young people, or projects set up by those who are socially excluded. The Trust also support innovative projects to promote excellence in teaching (at any level, from primary schools to universities), though we never support individuals. The Trust normally give grants to projects where an initial £75 to £750 can make a real difference to getting the project up and running. To be eligible, applicants need to be registered charities or have access to a registered charity that will be willing to accept funds on their behalf.

The quaintly sounding Society for the Assistance of Ladies in Reduced Circumstances has announced that it will be launching a new funding round in 2010. The Society, which was founded in 1886 and provides support to women resident in the United Kingdom who are living alone in their own home (either owned or rented) and in genuine need, irrespective of age or social status, will make £50,000 available for grants to support the work of other organisations that meet the objectives of the Society.

Priority will be given to smaller projects where it can be demonstrated that the Society's grant will make a real difference. The Society cannot consider projects which also benefit men, children or women who are not in financial need.
