#### Funding for Music Promoters (UK)

The PRS for Music Foundation, which is the UK's largest independent funder for new music, has announced that it is seeking applications for funding from promoters of Music of any genre, including unsigned band promoters. This funding scheme has two levels of funding. If you are applying for the first time, you are only able to apply for up to £3,000. If you wish to apply for more than £3,000, please email <u>applications@prsformusicfoundation.com</u>. To be eligible for funding, promoters will need to have at least one year's track record of promoting events; be promoting at least 8 events over a 12 month period (Making Music clubs must be promoting at least 3 concerts during this period); and be programming new British music of any genre. #### **Comic Relief Grants Programmes Open for Applications (UK)**

Comic Relief has announced that their UK grants programme is now open for applications. Applications will be invited from the voluntary and community sector throughout the UK including: constituted voluntary and community groups, charities, social enterprises, co-operatives, faith organisations, and community interest companies. Under its UK grant making programme, Comic Relief makes grants that: address mental health issues, domestic and sexual abuse, supports refugee and asylum seeking women; young people, in particular those that are sexually exploited and trafficked, that have alcohol and mental health problems; project that use sport to support community development and projects that support local disadvantaged communities. Comic Relief provides both capital and revenue and can pay for up to 100% of projects costs but they encourage applicants to get some of their funding from other sources. There is no minimum or maximum grant in most of the programmes, but where there are limits, these are clearly stated in the programme guidelines. Grants on average vary between £25,000 and £40,000 per year, and rarely exceed this upper limit.

#### New £2 million Access to Volunteering Pilot Fund Launched (England)

The Charities Aid Foundation (CAF) has announced the launch of a new £2 million Access to Volunteering Pilot Fund. Organisations in Greater London, the West Midlands and the North West can apply for grants of between £250 and £5,000, which can be used to help overcome barriers that stop disabled people volunteering, such as specific equipment, a lack of suitable access and understanding of disability issues. The fund operates between autumn 2009 and spring 2011. In addition to supporting disabled volunteers, the pilot will test different ways to apply for funds such as video applications and face-to-face pitches. The grant fund is being managed by a consortium comprising Charities Aid Foundation, RNIB and Digital Public. The next deadline for applications is the 8th February 2010. Additional deadlines are, the 19th April 2010, the 28th June 2010 and the 6th August 2010. #### Faith in Action Fund Round 2 Opens for Applications (England)

The Community Development Foundation has announced that a second funding round for its Faith In Action Programme is now open for applications. Faiths in Action is a £2 million grants programme sponsored by Communities and Local Government and administered by the Community Development Foundation that is open to faith, inter faith, voluntary and community sector organisations at national, regional and local levels in England. The aim of the fund is to support the government's aspiration to help faith communities and others to promote understanding, dialogue and develop strong and sustainable partnerships. The Fund is particularly keen to support projects that focus on the inclusion and participation of women and young people and those which involve partnerships between one or more organisations. Faiths in Action supports delivery of the Government document, Face to Face and Side by Side. All applications must therefore directly relate to one or more of the fund's four priorities which are derived from this framework. These are; developing the confidence and skills to "bridge" and "link"; supporting shared spaces for interaction and social action; developing structures and processes which support dialogue and social action; and improving opportunities for learning which build understanding.

#### Adult Learners' Week Awards (England)

The National Institute of Adult Continuing Education (NIACE) has announced that it is currently seeking nominations for the 2010 the Adult Learners' Week Awards. The aim of the Adult Learners' Week Awards is to reward and publicise the achievements of adult learners in England, to promote the benefits and to highlight the diversity, of adult education. The Awards also aim to encourage adult participation in learning. For the 2010 Awards, there are four main award categories. These are; individuals whose remarkable learning achievements have made a difference to their lives and can inspire others; Groups of three or more people who have come together for a common purpose and transformed their and/or other people's lives through learning; Families whose members have seen the benefits of learning together; and Opening Doors to Adult Learners which recognises creative and innovative projects or organisations that had a positive impact on the lives of their learners. Winners receive a learning voucher between £200 and £1,500 and are invited to an awards ceremony during Adult Learners' Week (15-21 May 2010). Entry is open to adult learners living in England only. Groups must consist of three or more members. All nominees must have undertaken some of their learning between January 2009 and January 2010.

#### Young Roots (UK)

Young Roots offers grants of between £3,000 and £25,000. The scheme aims to involve 13-20 year-olds (up to 25 for those with special needs) in finding out about their heritage, developing skills, building confidence and promoting community involvement. Projects need to be related to the local and culturally varied heritage of the UK. For example, it could involve young people researching a local archive or doing practical casework on a nature reserve. Projects must also show how young people are managing and participating in the project. Projects should promote social inclusion and equal opportunities by involving a wide range of young people of different abilities and cultural backgrounds.

#### Hilden Charitable Fund (UK)

The Hilden Charitable Fund has announced that the next deadline for submitting applications is the 29th January 2010. # Support for Young People Starting Up in Business (England, Scotland and Northern Ireland)

Young people wishing to start up their own business may be able to apply for funding and other support measures through the Prince's Trust Business Programme. The programme can provide

support to young people who are; aged 18-30; unemployed or working less than 16 hours a week; and living in England or Northern Ireland. The type of support available includes a low interest loan of up to £4,000 (up to £5,000 for a partnership); ongoing advice from a business mentor; access to a wide range of products and services. This includes a free legal helpline, sponsored by Barclays; a grant of up to £1,500 in special circumstances (subject to local availability); and a test marketing grant of up to £250 (subject to local availability). Young people in Scotland aged 18-25 may be eligible.

#### Funding for Music Making Activities (England)

Youth Music, the UK's largest children's music charity has announced its grant making programme is open for applications. Through its "Open Programme", grants of between £5,000 and £30,000 are available to support projects that provide music-making activities for children and young people in support of Youth Music's goals. Youth Music will fund any non profit-making organisation more than one year old that is committed to music-making activities for children and young people up to 18 (or up to 25 if they have special educational needs, disabilities or are in detention). Youth Music aims to support music making activities principally in out of school hours such as during weekends, holidays as well as in breakfast and after schools clubs. Youth Music understands that programmes may need to begin in school hours encouraging first time participation in music. To help with this, Youth Music will consider applications for programmes where up to 25% of the time is spent in school hours. The proposed programme should aim to encourage children and young people to eventually make music outside of school hours.

#### V's Match Fund Open to Applications (England)

Youth volunteering charity "V" has announced that they have £72 million available through their Match Fund to invest into diverse and high impact projects across England. Match Fund aims to encourage more investment in volunteering projects from businesses, charitable trusts and private individuals. The programme will match up to 100% of any new private investment involving young people aged 16-25. "V" is interested in supporting projects in six areas: Health and wellbeing, Environment, Supporting children and young people, Community cohesion, Poverty and Human rights. For one-year projects the minimum private contribution is £10,000, which will be match funded to the same amount by the programme. For two-year projects the minimum private contribution is £20,000. #### Austin and Hope Pilkington Trust

The Austin and Hope Pilkington Trust awards grants to charitable organisations in the United Kingdom and overseas. The trustees welcome applications for projects within the following areas for the next three years. These categories are then repeated in a three-year rotation:

• 2010: Children, youth, the elderly and medical. For this year only medical research projects dealing with the ageing population will be considered. The other priorities (children, youth and the elderly) as well as other non-research based medical work are still welcome;

2011: Music and the arts, overseas (deadline for applications: 1 June and 1 November 2011);
2012: Community (deadline for applications: 1 June and 1 November 2012). Due to the overwhelming number of applications received, the trustees have decided to consider within the community category applications only from charities working with homelessness, addiction, asylum and refugees, sexual and domestic abuse, prisoners and ex-offenders).

If your charity's work falls within one of these categories and would like to be considered for a grant, please submit an application by 1 June or 1 November only in the appropriate year. Grants are usually between £1,000 and £10,000, with the majority being £5,000 or less. Exceptionally, grants of up to £20,000 are made, but these are usually for medical research projects.

**Funding to Develop Media Skills for Disadvantaged Young People (England)** Mediabox which offers disadvantaged 13 to 19 year olds the opportunity to develop and produce creative media projects, using film, television, print, radio or online platforms has announced that its Big Mediabox funding programmes is now open for applications.

The scheme which is run by a consortium consisting of First Light Movies, Media Trust, Skillset and the UK Film Council provides grants of between £20,000 and £40,000 for media projects where disadvantaged young people (aged 13 to 19 years) take a lead role in all aspects of the production process. However participants with Learning Difficulties and Disabilities up to the age of 25 may be involved.

Applicants to Big Mediabox funding need to have a strong track record of developing media projects with young people and can include registered limited companies, local authorities, schools, colleges, universities and co-operatives. It is anticipated that through this funding round approximately 20 Big Media projects will be supported. Big Mediabox will fund up to 60% of the total cost of a project.

#### **Connecting Classrooms (England, Northern Ireland and Wales)**

Groups of schools and their local authorities/federations of schools in England, Northern Ireland and Wales are being invited to apply to the British Council's Connecting Classrooms programme to build lasting partnerships with schools China and Sub-Saharan Africa. Through these partnerships Connecting Classrooms aims to develop trust and understanding between young people in different societies, creating a safer and more connected world for the future. Connecting Classrooms offers grants to support the development of partnerships and to cover project-related costs. All applications must meet the following three requirements. Schools should not already be receiving funding; schools must apply with the right number of combination of schools in the cluster, i.e. nine schools, if applying for China or three schools if applying for Sub-Saharan Africa; and all schools in the cluster must have at least Foundation Level of the DCSF International School Award.
